**ORDER OF REMOVAL OF
STAY OF SUSPENSION**

This matter came before the Complaint Review Committee (“Committee”) of the Minnesota Board of Veterinary Medicine (“Board”) in accordance with the terms of a Stipulation and Consent Order (“2024 Consent Order”), which Gary Quimby, DVM, (“Licensee”), agreed to and signed on July 30, 2024.

Pursuant to the 2024 Consent Order, Licensee’s Doctor of Veterinary Medicine license was suspended, but the suspension was stayed contingent upon Licensee’s compliance with all terms and conditions set forth in the 2024 Consent Order. In paragraph 10 of the 2024 Consent Order, Licensee agreed that the Committee is authorized to issue an Order of Removal of Stay of Suspension (“Order of Removal”) if it has probable cause to believe Licensee violated any of the requirements for staying the suspension of Licensee’s license in the 2024 Consent Order.

The Committee has probable cause to believe Licensee violated one or more of the requirements for staying the suspension of Licensee’s license in the 2024 Consent Order.

This Order of Removal of Stay of Suspension constitutes disciplinary action by the Board and is classified as public data pursuant to Minnesota Statutes section 13.41, subdivision 5. Data regarding this action will be provided to data banks as required by Federal law or consistent with Board policy.

ORDER

1. NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension set forth in the 2024 Consent Order is **REMOVED**, and the license of Licensee as a Doctor of Veterinary Medicine in the State of Minnesota is **SUSPENDED** immediately.

2. IT IS FURTHER ORDERED that Licensee's license as a Doctor of Veterinary Medicine in the State of Minnesota shall remain suspended until the Board makes a final determination in this matter.

3. IT IS FURTHER ORDERED that Licensee's violation of this Order shall provide grounds for further disciplinary action pursuant to Minnesota Statutes section 156.081, subdivision 2(12).

4. IT IS FURTHER ORDERED that the Board shall conduct a hearing pursuant to paragraph 10 of the 2024 Consent Order. After that hearing, the Board may take any of the following actions:

a. Dismiss the Committee's allegations and reinstate Licensee's license under the terms of the 2024 Consent Order.

b. Reinstate Licensee's license with limitations placed upon the scope of Licensee's practice and/or conditional upon further reports to the Board.

c. Continue the suspension of Licensee's license.

d. Impose any other form of discipline permitted by Minnesota Statutes section 156.081.
