### **7. Counseling Compact Presentation.**

Greg Searls, Executive Director of the Counseling Compact, presented on the Counseling Compact. In his presentation he noted that only LPCCs in Minnesota will be eligible for the Compact, you must live in a Compact state to join, professionals must practice legally in the state where they are practice, and states retain control of scope of practice and initial licensing requirements.

After the presentation, Board members discussed who should represent the Board as Compact Commissioner and Temporary Representative. Roy Kammer moved to appoint Samantha Strehlo as Commissioner and Megan Morgan as Temporary Representative. Randy Anderson seconded. The following Board members voted to approve the motion: Bharati Acharya, Christopher Anderson, Randy Anderson, Jackie Bluem, Sandy Clark, Sarah Driever, Dean Gilbertson, Corey Harland, Roy Kammer, Landyn Prescott-Miles, Randy Stillday.

The Compact legislation allows the Board to assess a state fee on those who apply for a privilege to practice in Minnesota. The Board discussed fee amounts. Before making a decision, the Board asked staff to collect information on what other Board in Minnesota plan to charge and what other states that are a part of the Compact plan to charge. The fee amount does need to go through the legislative process. Board members agreed that “do not exceed” language should be added so the Board can adjust the fee amount as needed.

### **8. Application and Licensure Committee**

a. Variance request-Joanna Rosa, MS, LPCC. Licensee requested a variance to Minnesota Rules related to. Specifically, Licensee requested that the Board waive the requirement that LPC supervisors have fours years of professional counseling experience. Jackie Bluem motioned to approve the variance. Corey Harland seconded. The following Board members voted to approve the variance: Bharati Acharya, Randy Anderson, Jackie Bluem, Sandy Clark, Sarah Driever, Dean Gilbertson, Corey Harland, Roy Kammer, Landyn Prescott-Miles, Randy Stillday. The bill as currently drafted would house the art therapy license with the Board. Christopher Anderson moved that the Board take that position that Board members should not determine if another profession should be regulated, and that if the Legislature determines that art therapist should be licensed and regulated by the Board, we will do what we can to assist. Roy Kammer seconded.
