#### **New Chair**

Dr. Mark Roszkowski introduced himself as a newly appointed board member and new chair of the Sedation Committee.

#### Pediatric Sedation Cases and Rule Modification

The Committee discussed Minnesota Rules Part 3100. The new rules, which are in effect, provide requirements to receive the initial endorsement for pediatric anesthesia for both conscious sedation providers, general anesthesia or deep sedation providers. Some providers have not had enough cases to meet the criteria for 12 pediatric cases in the timeline prior to applying and getting approval for the initial endorsement. The Committee considered requiring

attestation for endorsement renewal to allow time to obtain required cases; and then the 12 pediatric cases in 12 months would be required for future renewals.

MOTION: Mark Roszkowski made a motion to pursue rule modification to allow initial endorsement approval for licensees who have 12 cases within the 24 months preceding application. Heidi Donnelly second.

**RESULT: Motion passed** 

Individuals may continue to apply for variances at this time on a case-by-case basis. The Board will consider pursuing a future rule change.

### IV Sedation Program Consideration – Colorado Surgical Institute

The Committee reviewed the Colorado Surgical Institute's course for moderate conscious sedation and agreed the course meets or exceeds criteria for Minnesota's conscious sedation training requirement. Discussion included course content, live patient cases, and instructors' criteria.
