2. He shall read the Model Policy for pain control published by the Federation of State Medical Boards and *Responsible Opioid Prescribing, A Clinician's Guide*, 2nd edition, by Scott M. Fishman, M.D.
3. He shall complete, within one year, the following pre-approved courses:
 - Chronic pain management.
 - Boundaries.
4. He shall maintain records that reflect the patient complaint, clinical findings, treatment plan, response to treatment, and prescriptions authorized, including refills.
5. Six months following his successful completion of the pre-approved courses, he shall undergo an audit of his prescribing practices.
6. He shall practice in a pre-approved setting.
7. He shall develop, and submit for Committee approval, a narcotics agreement.
8. He may petition for reinstatement of an unconditional license upon completion of the terms of his Order.
