

Agreements of the Minnesota Board of Physical Therapy

Agreement for Corrective Action:

An Agreement for Corrective Action is a contract between the Complaint Review Committee and the respondent (individual under investigation) in which the respondent agrees to take certain remedial action, usually educational, to correct problems identified in the Complaint Review process.

Corrective Action is not disciplinary action, but it is a public document. The Agreement is ratified by the Committee chair and does not require action by the full Board. After the terms of the Agreement have been fulfilled to the Committee's satisfaction, the investigation is closed and a public closing letter is sent to the Licensee.

Minnesota Statute Chapter 214.072 (a) (3) (2013) requires corrective actions be posted on the Board's website.
