Unfinished Business

- a. Number of Collaborative Hygienists Agreements -Ms. Anderson brought back from Executive Committee to Allied for vetting of a process. Ms. Anderson recommends if they want 8-10, for instance, they would need to provide additional information. We could have them come to the Committee with their scenario and information for wanting to have more than four collaborative hygienists, and the committee can review on a case by case basis.

- b. DASLE Review Sessions & Test Construction –Ms. Anderson indicated that the first review session is scheduled for May. Would like more discussion and committee feedback on the Orthodontia questions, as there are 22 questions in the current exam. Hoping to have more of a breakdown for passing rate at next meeting. Instructors can take DASLE as well, would be a great learning tool. Dr. Ismail suggested more technical questions that would be used in clinical – these are also included in the Jurisprudence Exam (laws applicable to MN). Ms. Donnelly suggested changing the questions; the challenge is getting it done by May. There are also no pediatric questions on the DASLE. Ms. Anderson will schedule follow up with Dr. Ismail for exam review.
- c. Consider Allied Orthodontic course by UMN – This would be a CE (Continuing Education) course that the UMN could offer to those that are interested, and would be available to dental assistants. Ms. Anderson did provide the Board with the curriculum for ortho duties and comparison to UMN proposed course. Ms. Drake indicated that the UMN wants to offer as a Certificate. Committee unanimously supported the course. B. Anderson will follow up with Dr Grunheid.
