• Bipolar: 7%





COVID-19 & HPSP

- Immediately move staff to staggered schedules
- Utilize additional technology and implement some telecommuting
- Implement robust cleaning efforts and wearing masks
- Address participant issues:
 - Collection site closures
 - Limited in-person assessments (substance use and psychiatric)
 - Elimination of in-person mutual support groups
 - Near elimination of in-person intensive outpatient treatment
 - Quarantines

COVID-19 & HPSP Participants

- Employment:
 - Furloughs or job loss
 - Stress related to changes in responsibilities
 - Fear of getting COVID from patients/clients
- Life management
 - Isolation/Anxiety
 - Normal support systems not available or limited
- Substance use disorders (assessments, treatment, collection sites, and telehealth)
- Mental health disorders (assessments, treatment and telehealth)
