a. **Discussion of Guest Volunteer Licensure:**

Dr. Christopher Schmaltz brought forth a proposal for the Committee to consider regarding creating a renewal process for a Guest Volunteer license. Dr. Schmaltz works for the Red River Valley Project and identified that they have lost a number of volunteer dentists from out state, due to the fact that they have to re-apply for this type of license annually.

The Committee supported creating a renewal process, acknowledging that there is no fee for this type of license, but that the application process can be time consuming and requires resubmission of documentation each year. They directed the Board's Executive Director, Bridgett Anderson to bring back draft language to discuss at their next open session.
