**ORDER OF REMOVAL OF  
STAYED SUSPENSION**

This matter came on before the Complaint Committee (“Committee”) of the Minnesota Board of Dentistry (“Board”) in accordance with the terms of a Stipulation and Order for Stayed Suspension and Conditional License adopted by the Board on May 2, 2014 (“2014 Order”), which JoAnn M. Bassing, D.D.S. (“Respondent”), agreed to and signed.

Pursuant to the 2014 Order, Respondent’s license was suspended, but the suspension was stayed contingent upon Respondent’s compliance with all terms and conditions set forth in the 2014 Order. In paragraph 15 of the 2014 Order, Respondent acknowledged and agreed that the stay of suspension could be removed if she failed to comply with or violated any of the requirements for staying the suspension.

The Committee has probable cause to believe Respondent has failed to comply with or has violated one or more of the requirements for staying the suspension of Respondent’s license.

**ORDER**

1. NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension set forth in the 2014 Order is **REMOVED**, and the license of Respondent to practice dentistry in the State of Minnesota is **SUSPENDED** immediately.

2. IT IS FURTHER ORDERED that Respondent’s license to practice dentistry in the State of Minnesota shall remain suspended until the Board makes a final determination in this matter.

3. IT IS FURTHER ORDERED that Respondent surrender to the Board her Dentistry registration certificate. Respondent shall personally deliver or mail the certificate to

the Minnesota Board of Dentistry, c/o Marshall Shragg, Executive Director, Suite 450, 2829 University Avenue S.E., Minneapolis, Minnesota 55414, within five days after receipt by Respondent of this Order.

4. IT IS FURTHER ORDERED that Respondent's violation of this Order shall provide grounds for further disciplinary action pursuant to Minnesota Statutes section 150A.08, subdivision 1(13) (2012).

5. IT IS FURTHER ORDERED that the Board may, at any regularly scheduled meeting following service of this Order of Removal and a Notice of Removal of Stay of Suspension, Imposition of Suspension, and Hearing upon Respondent in accordance with the requirements of the 2014 Order, take any of the following actions:

- a. Dismiss the Committee's allegations and reinstate Respondent's license under the terms of the 2014 Order.
- b. Reinstate Respondent's license with limitations placed upon the scope of Respondent's practice and/or conditional upon further reports to the Board.
- c. Continue the suspension of Respondent's license.
