Read This Registration Form Completely and Carefully

Information relating to your practice of dispensing legend drugs for profit is required under Minnesota Statutes, Chapter 151.37, subdivision 2b (1994), and is classified as public data under Minnesota Statutes, Chapter 13.03. This information will become part of your license record maintained by the Minnesota Board of Dentistry.

If you do not file a statement relating to your practice of dispensing legend drugs for profit within **30 days** from your initial licensure date, your license record will reflect that you did not respond to this registration notice.

This is the only notice you will receive from the Board relating to your practice of dispensing legend drugs for profit. If you change your practice of dispensing legend drugs for profit after filing this initial form, you must notify the Minnesota Board of Dentistry in writing of the change.

Dear Doctor:

Minnesota Statutes, Chapter 151.37, subdivision 2b (1994) requires a licensed practitioner that dispenses for profit a legend drug that is administered orally, is ordinarily dispensed by a pharmacist, and is not a vaccine, to file with the practitioner's licensing board a statement indicating that the practitioner dispenses legend drugs for profit, the general circumstances under which the practitioner dispenses for profit, and the types of legend drugs generally dispensed. It is unlawful to dispense legend drugs for profit after July 31, 1990, unless the statement has been filed with the appropriate licensing board.

To determine whether or not you dispense legend drugs for profit, please review the following definitions as they relate to **DISPENSING FOR PROFIT**.

1. **PROFIT** means any amount received by you in excess of the acquisition cost of a legend drug that is purchased in a prepackaged form;

OR

2. **PROFIT** means any amount received by you in excess of the acquisition cost of a legend drug, plus the cost of making the drug available if the legend drug requires compounding, packaging or other treatment.

If you are prescribing, dispensing and billing for legend drugs and the amount you receive is greater than your acquisition cost, you must indicate that fact on the enclosed form and return the form to the Board office in the envelope provided. You are not permitted to dispense legend drugs for profit without first registering with the Board.

If you **DO NOT** dispense legend drugs for profit, please indicate that fact on the enclosed form and return the form to the Board office in the envelope provided.
