Agenda Item 3: Report of New Credentials, April 29, 2025, through July 2, 2025

The Board's Agenda included an informational report of licenses issued between April 29, 2025, and July 2, 2025.

Agenda Item 4: June 18, 2025, Policy & Planning Committee Report & Motion

Kristina Krohn, M.D., Chair of the Policy & Planning Committee ("Committee") presented her report and the motion from the Committee for the Board's consideration.

Motion: Submit public comment to the draft of the second set of recommendations from the Advisory Commission on Additional Licensing Models regarding assessment of alternative pathways to licensure.

Dr. Krohn presented the eight recommendations from the Advisory Commission on Additional Licensing Models. She shared that the Committee noted appreciation for all of the recommendations and talked through the public comment to be shared specific to recommendation #1 regarding assessment during the supervisory period, including the request for more clarity regarding the level to which the limited license holder should be assessed. Dr. Krohn noted the importance of having that level of mastery be the equivalent of what is expected in that jurisdiction for physicians obtaining licensure through other pathways.

Dr. Krohn also discussed the new legislation that passed this legislative session regarding a limited license for graduates of foreign medical schools. There was much discussion regarding this new license type including additional obligations the Board may have around implementation, assessment, supervision and determination of equivalency of competency at the end of the limited license period. The Board further discussed the possibility of asking the legislature to consider adding a requirement that the supervising physicians for the limited license holder must have an active and unrestricted license.

Agenda Item 5: May 13, 2025, Health Professionals Services Program, Program Committee Report

Ms. Turner shared her report from the May 13, 2025, Health Professionals Services Program, Program Committee. A presentation was given about the *Treat Yourself First Coalition* around burnout among healthcare professionals. Ms. Turner shared a brief overview of the presentation, including the importance of breaking the stigma of healthcare professionals seeking mental health services.

Ms. Turner concluded her report.

Agenda Item 6: 2025 Federation of State Medical Boards (FSMB) Annual Report

The 2025 Federation of State Medical Boards (FSMB) Annual Report was shared with the Board. No Action was needed.

Agenda Item 7: Executive Director's Report

Elizabeth Huntley presented her Executive Director's Report.

Legislation: The Minnesota legislature held a special session on June 9, 2025. During that session, the Health and Human Services bill passed that included the agency's biennial appropriation, as well as the internationally trained physician legislation and the expansion of physicians with whom a physician assistant can work for their required collaborative practice hours. Specifically, physician assistant collaborative practice hours can now be with a physician licensed in any U.S. state or territory, and not only a Minnesota licensed physician as the legislation was originally passed in 2020. Ms. Huntley thanked licensure staff, Kita Nelson and Paul Luecke, along with Mark Chu from MNIT for their efforts getting that legislative change implemented in under three weeks.

Federation of State Medical Boards: The Federation of State Medical Boards is once again offering a three-part educational series for new Board members. The first session was held in June, the second session will be in July and the final session in August. If Board members would like to register for either of the remaining sessions, and need help, please contact Eden Young or Elizabeth Huntley.

Staff Updates – Tiernee Murphy, Bryan Shirley and Brian Anderson all recently had the opportunity to attend educational conferences. Specifically, Ms. Murphy attended the New Director Orientation at the Federation of State Medical Boards office in Texas. Mr. Shirley and Mr. Anderson attended the Investigators in Training course offered by the Administrators in Medicine. Ms. Murphy and Mr. Shirley shared a brief overview about their experiences and thanked the Board for its support of professional development.

Other Business – Ms. Huntley noted working on the Board's Internal Controls Assessment Tool, an annual exercise completed in collaboration with the Internal Controls at the Minnesota Department of Management and Budget and SmART. The assessment has the Board reflecting on everything from agency culture, including professionalism and ethical behavior, to purchasing and contracting processes, data protection and payroll processing.

Ms. Huntley reminded the Board that the discussion from the last meeting regarding expanding more postgraduate training accreditation program continues. The Board is in the process of creating a work group to create a framework to review and assess these programs and in the meantime, the Board's Policy & Planning Committee will serve as the first audience and reviewer for programs to present information about who they are and what their accreditation process includes.

Ms. Huntley thanked Board members for the heartfelt, thoughtful, and supportive feedback that was shared as part of her annual performance review. Ms. Huntley recognized the incredible amount of great work the Board and its staff does and noted that strategic planning for the Board is being explored.

Ms. Huntley concluded her Executive Director's Report.

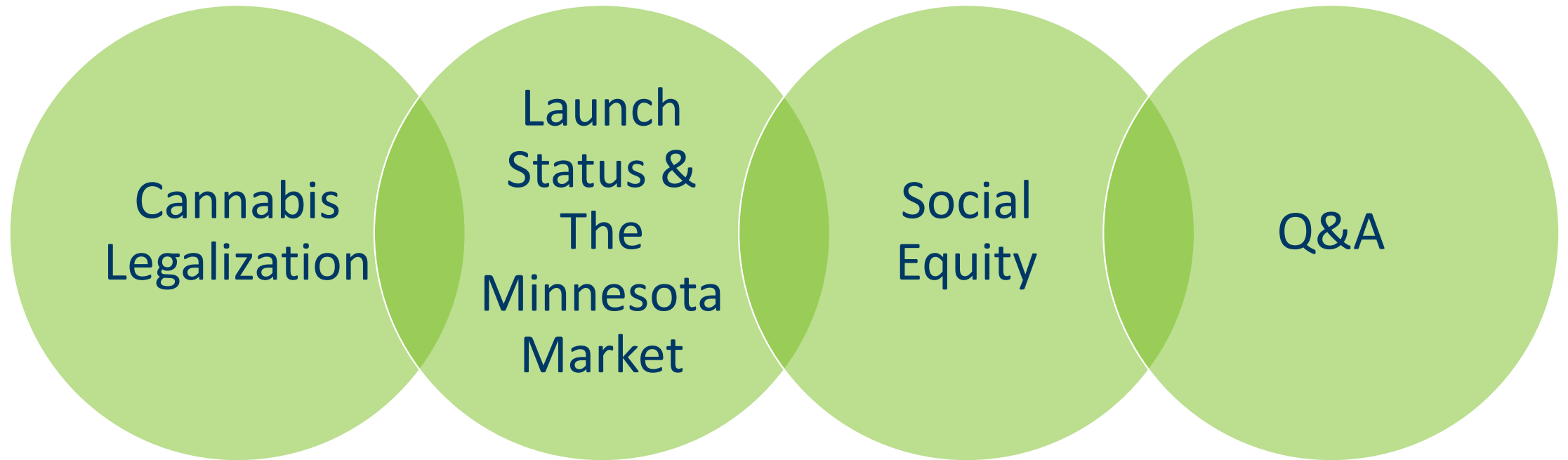

 - Providing for the licensing, inspection, and regulation of cannabis and hemp businesses
 - Establishing a license preference for social equity applicants
 - Requiring testing and labeling of cannabis and hemp products
 - Creating grants and loan programs to assist people entering the legal cannabis market

Cannabis Legalization in Minnesota

- Effective Aug. 1, 2023, full decriminalization will allow the possession, use, and home grow of cannabis in Minnesota for people 21 and older.
As outlined in law, a person age 21 or older may:
 - Use, possess, or transport cannabis paraphernalia.
 - Possess or transport up to 2 ounces of cannabis flower in a public place.
 - Possess up to 2 pounds of cannabis flower in a person's private residence.
 - Possess or transport up to 8 grams of adult-use concentrate.
 - Possess or transport edible cannabis products or lower-potency hemp edibles infused with a combined 800 milligrams or less of THC.
 - Give away cannabis flower and products to a person 21 or older in an amount legal for a person to possess in public.

Where can cannabis be used?

- Cannabis can be used by people 21 and older on private property (unless the owner prohibits use of cannabis on their property), private residences and at places with approved licenses or an event permit (however, no licenses or event permits are available at this time).

Cannabis *cannot* be used when operating a motor vehicle or operating heavy machinery and where smoking and vaping are prohibited under the Minnesota Clean Indoor Air Act.

Cannabis *cannot* be used or possessed in the following locations:

- Public school or charter schools and school buses
- State correctional facilities
- In a location where the smoke, aerosol or vapor of a cannabis product could be inhaled by a minor
- On federal property (such as courthouses, airports and national parks)
- In federally subsidized housing. Due to the federal prohibition of cannabis, the U.S. Department of Housing and Urban Development (HUD) does not have the discretion to admit or retain users of cannabis (i.e., marijuana), including medical cannabis, to the public housing program.
- While on an employer's premises, or operating an employer's vehicle, machinery or equipment

Where can cannabis be used?

- Smoking or vaping adult-use cannabis products is prohibited in a multifamily housing building, including patios and balconies. OCM has the authority to assess a fine of \$250 if there is clear evidence showing a person has violated [Minnesota Statutes, section 342.56, subd. 1\(b\)](#). [Submit a complaint to the Office of Cannabis Management](#).
- Owners of day cares must disclose to parents if the proprietors permit use of cannabis outside of its normal business hours.
- NOTE: Communities may have local ordinances that prohibit smoking or vaping cannabis in public places.

Safe and Responsible Use

- Cannabis should always be used responsibly and never used before driving a vehicle or operating heavy machinery. Driving under the influence of cannabis is illegal and subject to additional DWI sanctions. Learn more at the [Minnesota Office of Traffic Safety](#).
- If you are pregnant or breastfeeding, have been diagnosed with or are predisposed to serious mental illness, talk with your health care provider before using cannabis.
- To avoid dangerous interactions with prescribed medications, talk to your health care provider or pharmacist before using cannabis.
- Make sure your cannabis is stored safely. Keep your products in child-resistant packaging, clearly labeled and locked up.
- If you think your cannabis use is disrupting your daily life or causing problems at home, work, or school, talk to your health care provider or substance use counselor.

What's allowed if a person wants to grow cannabis at home?

- Up to eight cannabis plants, with no more than four being mature, flowering plants may be grown at a single residence as long as it is at the primary residence of someone 21 or older.
- Plants must be in an enclosed, locked space that is not open for public view.

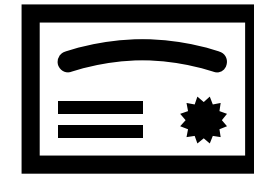
Rulemaking

- The rules governing Minnesota's adult-use cannabis industry are formally adopted and in effect, after being approved by an administrative law judge and published in the Minnesota State Register on Monday, April 14.

From Start to License: Your Path to Cannabis Licensing in Minnesota



Before you begin:

1. Were you verified as a social equity applicant? If so, decide if you will apply for a social equity-classified license.
2. What license type will you apply for? What endorsement(s) will you need to obtain?
3. Talk to your local government about zoning requirements and local retail registration availability (if applicable).

Start here! Step 1. Complete your application

Create your account in Accela, OCM's business licensing system.

Review OCM's application guidance and prepare your required application documents.

Begin your application. Fill in all required information and attach required documentation when prompted.

Pay your application fee.
OCM reviews your application for minimum qualifications.

Your local government confirms your site meets all zoning regulations and other local rules and ordinances.

OCM sends your application to your local government for approval of zoning compliance**, while continuing internal review.

OCM has 90 days to review your application upon your site registration submission.

Submit final plan of record documents to OCM including site information.

Incomplete final plans of record will lead to delays in approving your license.

Secure your business location and confirm it meets local government requirements.

Step 2a. Uncapped license approval

Your application passes! You are now a **qualified applicant**.

Complete required background check(s) and submit your labor peace agreement* to OCM.

You are now a **preliminarily approved applicant**.

Step 2b. Capped license approval

Your application passes! You are now entered into a randomized lottery selection.

Your application is chosen in the lottery! You are now a **qualified applicant**.

You pass the inspection! You are now a **pending license holder**.

Your business undergoes a full pre-licensure inspection by OCM.

Step 4. Pre-licensure inspection

Step 5. License issuance

Pay the initial license fee, if applicable, in Accela.

OCM issues your cannabis business license and Metrc registration directions.

You are now a **license holder** and may begin operations.***

Step 3. Final plan of record submissions, site registration, local government approval



* Microbusinesses are exempt from the labor peace agreement requirement until the point of renewal.

** Your application cannot proceed and your business cannot open until your local government certifies that your business meets zoning compliance, and, if applicable, fire code and building code.

*** For those seeking to conduct retail activities, you must get retail registration from your local government directly (in addition to your license) before beginning cannabis sales. Local governments can issue local retail registration once you have preliminary license approval or have been issued a license from OCM.



Complete the checklist for Step 3 on page 2 of this document before submitting your site registration.

Note: Applicants have 18 months to complete Steps 3-5.

Preliminarily Approved Applicant Checklist



Preliminarily approved applicants **should not** start site registration (Step 3) in Accela until they have received the preliminary approval email from OCM. Complete all items in Step 3 (see checklist below) **before** submitting a site registration.

Step 3. Site registration, final plan of records, and local government approval



- ☐ Secure your site location and confirm it meets local government requirements.
 - ☐ Verify with your local government that your site will meet zoning compliance.*
 - ☐ Check whether or not your local government enforces building and fire codes. If they do, work with your local government to ensure your site meets those codes.
 - ☐ Check with your local government about other land use or local ordinance compliance approvals (i.e. permits to occupy and operate your business at the location).
 - ☐ If you are conducting retail sales, check with your local government on whether there is a retail registration cap before proceeding.
- ☐ Complete final plans of record and submit in Accela under Site Registration.
 - Access the required fillable online forms using the links provided on OCM's [Final Plan of Record Submission webpage](#).
 - Upon completing the online forms, you will be emailed a PDF copy of your plans. All PDFs need to be uploaded in Accela on the second step (site information) of the site registration page, along with your updated capitalization table (if applicable) and any files that were larger than 10MB and unable to be uploaded to the online forms.
 - Take your time, the quality of the plans is crucial. If these are not fully complete, you will experience delays in receiving your license as you will have to restart your final plans of record. OCM cannot conduct inspection until plans are approved.
- ☐ Register your final site location information to OCM in Accela.
 - Upon submitting your site registration, which includes final site location information and final plans of record, OCM will have 90 days to review your application.

** If you have preliminary approval, you can secure zoning confirmation directly from your local government and then work on final build out of your site, ensuring that is all complete at time of site registration with OCM.*

Step 4. Pre-licensure inspection



- ☐ OCM schedules a full pre-licensure inspection for your business after local government approval is received in Accela and final plans of record are approved.
- ☐ Your business undergoes the inspection by OCM.
- ☐ Pass your inspection and become a pending license holder.
- ☐ OCM will complete the inspection report and send an initial license fee invoice, if applicable.

Step 5. License Issuance



- ☐ Pay the initial license fee in Accela, if applicable.
- ☐ OCM issues your license.

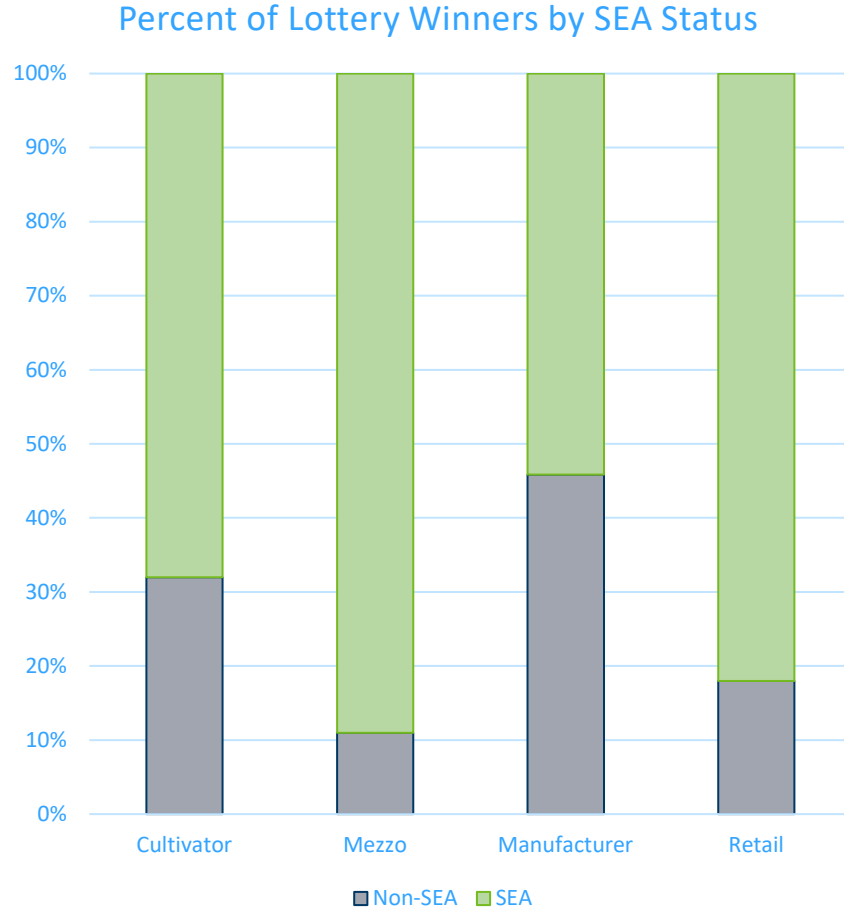

**STIPULATION TO CEASE
PRACTICING MEDICINE**

WHEREAS, the Minnesota Board of Medical Practice ("Board") received a report related to alleged activities that would affect the license to practice medicine and surgery of Buck Bania, M.D. ("Respondent");

WHEREAS, Respondent was licensed by the Board to practice medicine and surgery in the State of Minnesota on July 13, 2013;

WHEREAS, the report alleged that, in March 2024, Respondent's Alaska medical license was voluntarily surrendered under disciplinary order due to allegations of sexual misconduct and the Board received confirmation that Respondent petitioned for reinstatement of his Alaska medical license and a hearing is scheduled for August 2025;

WHEREAS, the report alleged Respondent engaged in unethical or improper conduct, including, but not limited to: conduct likely to deceive or defraud the public; conduct likely to harm the public; conduct that demonstrates a willful or careless disregard for the health, welfare, or safety of a patient; medical practice that is professionally incompetent; and conduct that may create unnecessary danger to any patient's life, health, or safety in any of which cases, proof of actual injury need not be established;

WHEREAS, the report alleged Respondent engaged in conduct with a patient which is sexual or may reasonably be interpreted by the patient as sexual, or in any verbal behavior which is seductive or sexually demeaning to a patient;

WHEREAS, if the allegations are proven true, Respondent has engaged in conduct that is in violation of Minnesota Statutes sections 147.091, subdivision 1 (d), (g), and (t) (2024); and

WHEREAS, the Board initiated an investigation relating to the alleged activities that could affect the license of Respondent to practice medicine and surgery.

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between Respondent and the Board, that:

1. During all times herein, Respondent has been and now is subject to the jurisdiction of the Board from which he holds a license to practice medicine and surgery in the State of Minnesota.

2. Respondent agrees to refrain from practicing medicine in any manner in the State of Minnesota and shall neither offer nor provide any medical services of any nature within the State until such time as the Board has resolved the allegations pending against him.

3. This Stipulation shall be in effect until: (a) the Board issues a final order, which may occur after a contested case proceeding held pursuant to Minnesota Statutes chapter 14; (b) the Board adopts a final stipulation between the parties; or (c) the Board dismisses the proceedings against Respondent or determines that disciplinary action is not warranted.

4. Respondent agrees to notify the Board in writing within five (5) days of the final resolution of his petition for reinstatement of his Alaska medical license.

5. Respondent's violation of this Stipulation shall be considered a violation of Minnesota Statutes Chapter 147 and constitute independent grounds for disciplinary action.

6. Respondent agrees that should he violate the terms of this Stipulation, the following actions may be taken:

a. The Board may, pursuant to Minnesota Statutes Chapter 14 (2024) and Minnesota Rules 1400.5100 to 1400.8400 (2024), refer any alleged violation of this Stipulation to the Court of Administrative Hearings.

b. Should a violation be alleged, Respondent agrees that the issue before the administrative law judge may be limited as to whether a violation of this Stipulation did in fact occur and whether there was sufficient or reasonable cause to excuse such violation. If the administrative law judge finds that there has been a violation and there is not sufficient or reasonable cause to excuse such, he or she may make a recommendation of discipline.

c. Respondent agrees that in the event the Board receives findings of the administrative law judge that there has been a violation of this Stipulation, the Board may order a suspension or revocation of Respondent's license to practice medicine or such lesser action or remedy as the Board deems appropriate.


d. Upon application of the Board, any appropriate court may enter a decree enforcing the terms of this Stipulation and prohibiting Respondent's practice of medicine until and unless the conditions of this Stipulation are fulfilled.


7. This Stipulation shall be classified as public data for purposes of Minnesota Statutes sections 13.02, subdivision 15, and 13.41, subdivision 5 (2024). Data regarding this Stipulation may be provided to data banks as required by federal law or consistent with Board policy.

8. Respondent has been advised by Board representatives that he may choose to be represented by legal counsel in this matter. Respondent is represented by Melissa M. Heinlein, Heinlein Law, PLLC, 309 Clifton Avenue South, Minneapolis, Minnesota 55403.

9. This Stipulation contains the entire agreement between the Board and Respondent, there being no agreement of any kind, verbal or otherwise, which varies this Stipulation.
