ii. Report on Program Operations. Moni had no updates to share regarding program operations.

5. Variance Requests.

a. LPC Applicant #130506. Applicant requested a variance to Minnesota Rules 2150.5010, subpart 4.D. related to the requirement that supervision must be completed in no fewer than 12 consecutive months and no more than 36 consecutive months. Specifically, Applicant asked the Board to grant her additional time to complete the required 2,000 hours of supervised practice. Chair Derrick Crim moved to approve. Roy Kammer seconded. After a recommendation from Samantha Strehlo that the motion include a time limit, Chair Crim amended his motion. Chair Crim moved to grant Applicant a 36-month extension to complete the 2,000 of supervised practice. Kammer seconded the amendment. The following Board members voted to approve the variance: Bharati Acharya, Jacqueline Bluem, Derrick Crim, Amy Dols, Corey Harland, Roy Kammer, Landyn Prescott-Miles, and DeDe Van Slyke.

b. LPCC Applicant #136593. Applicant requested a variance to Minnesota Rules 2150.5010, subpart 4.A and Minnesota Rules 2150.5010, subpart 4.D. related to the requirements that supervision must be completed with an approved supervisor and that supervision must be completed in no fewer than 12 consecutive months and no more than 36 consecutive months (24 consecutive months and 72 consecutive months for LPCC supervision). Specifically, Applicant asked the Board to accept hours she completed with a nonapproved supervisor and supervised practice hours completed in more than 72 months. Chair Derrick Crim moved to approve. Corey Harland seconded. Applicant was present at the meeting and provided information about her request. The following Board members voted to approve the variance: Bharati Acharya, Jacqueline Bluem, Derrick Crim, Amy Dols, Corey Harland, Roy Kammer, Landyn Prescott-Miles, and DeDe Van Slyke.

6. Policy and Rules Committee.

Strehlo provided an overview of the Policy and Rules Committee meeting on May 19, 2022. At the meeting, Committee members reviewed public comments related to the Board's proposed rules. Most of the feedback the Board received was positive. After reviewing the comments, the Committee made a couple of minor changes to the draft language to clarify language related to the rate of supervision and added the definition of in person supervision that was adopted in statute during the Legislative Session. Roy Kammer moved to approve the changes to the proposed rules. DeDe VanSlyke seconded.
