**AGREEMENT FOR
CORRECTIVE ACTION**

This Agreement is entered into by and between Lydia Rasmussen, LALD, LNHA ("Licensee"), and the Standards of Practice Committee ("Committee") for the Minnesota Board of Executives for Long-Term Services and Supports ("Board") based on Minnesota Statutes section 214.103, subdivision 6(a)(2). Licensee and the Committee agree to the following:

FACTS

1. On October 8, 2014, the Board granted Licensee a Nursing Home Administrator ("NHA") license.
2. On May 6, 2021, the Board granted Licensee an Assisted Living Director ("ALD") license.
3. Since November 20, 2023, Licensee has been the Administrator of Record ("AOR") for a skilled nursing and rehabilitation facility in St. Paul, Minnesota ("facility").
4. In July 2024, the Minnesota Department of Health issued Immediate Jeopardy ("IJ") tags on three separate occasions for violations occurring at the facility. Licensee disputes the findings for two of the determinations. Licensee admits, however, that on July 11, 2024, a resident's ventilator alarmed intermittently 237 times between 3:19 a.m. and 5:47 a.m. without staff response.

CORRECTIVE ACTION

5. The Committee determined that the conduct described in paragraph 4, above, does not comply with Minnesota Rules 6400.6900, subpart 1.I. (unprofessional conduct), 1.J. (failed

to exercise true regard for safety, health, or life of a resident), and 6400.7095, subpart 1.I. (unprofessional conduct) and necessitates the following corrective action as described below.

a. **Education.** Within six months from the date of this Agreement, Licensee shall obtain at least four (4) hours of education on the topics of quality assurance process improvement. Licensee shall submit the proposed course(s) for preapproval by the Committee within 30 days of the date this Agreement becomes effective. The Committee reserves the right to reject the course(s) proposed by Licensee.

b. **Self-Report.** Within 30 days of completing the course(s) described above, Licensee shall submit a report stating Licensee's understanding of the role and responsibilities of nursing home administrators and assisted living directors and how Licensee plans to apply the concepts learned to Licensee's practice. Final determination regarding successful completion of the education shall be at the discretion of the Committee.

OTHER INFORMATION

6. Upon Licensee's satisfactory completion of the corrective action referenced in paragraph 5 above, the Committee agrees to dismiss the complaint(s) concerning the matters referenced in paragraph 4. The Committee shall be the sole judge of satisfactory completion. The Committee may reopen this complaint if it receives newly discovered information that was not available to the Committee during the initial investigation or if the Committee receives a new complaint that indicates a pattern of behavior or conduct.

7. If Licensee fails to complete the corrective action satisfactorily, the Committee may, at its discretion, reopen the investigation and proceed according to Minnesota Statutes sections 144A.19 to 144A.37 (the Board's Practice Act) and chapters 214 and 14. Licensee agrees that failure to complete the corrective action satisfactorily is failure to cooperate under

Minnesota Rules 6400.7905, subpart 1.U. and may subject Licensee to disciplinary action by the Board.

8. Licensee is represented by Rob Rodè, Esq., of Rodè & Coffin, LLC, St. Paul, Minnesota. The Committee was represented by Alex Mountain, Assistant Attorney General.

9. This agreement shall become effective upon execution by the Board's Executive Director and shall remain in effect until the Committee dismisses the complaint, unless the Committee receives additional information that renders corrective action inappropriate. Upon receiving such information, the Committee may, at its discretion, proceed according to Minnesota Statutes sections 144A.19 to 144A.37 (the Board's Practice Act) and chapters 214 and 14.

10. This agreement is not disciplinary action. See Minnesota Statutes section 214.103, subdivision 6. However, this agreement is classified as public data pursuant to Minnesota Statutes section 13.41, subdivision 5.

11. Licensee hereby acknowledges having read and understood this agreement and having voluntarily entered into it. This agreement contains the entire agreement between the Committee and Licensee, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this agreement.
