**STIPULATION TO CEASE  
PRACTICING AS AN ASSISTED  
LIVING DIRECTOR**

1. The Minnesota Board of Executives for Long-Term Services and Supports ("Board") has an obligation under Minnesota Statutes chapters 144A and 214 to license and regulate assisted living directors in the State of Minnesota, and to take disciplinary action as appropriate.

2. Fatou Jallow, LALD ("Licensee"), is licensed by the Board to practice as an Assisted Living Director in the State of Minnesota. Licensee has applied for and received a shared assignment to serve as an ALD for four other facilities. Licensee is subject to the jurisdiction of the Board.

3. The Board received information alleging that Licensee has violated Minnesota Rules section 6400.7095, subparts 1 (E) and (I) which, if proven, could affect Licensee's license.

4. In 2022, the Minnesota Department of Health ("MDH") investigated an allegation of maltreatment and substantiated that Licensee neglected a resident resulting in the resident's death. Licensee disputes the facts and has appealed the MDH determination. The case is ongoing.

5. In 2024, the Minnesota Department of Health ("MDH") investigated an allegation of maltreatment and substantiated that Licensee neglected a resident. Licensee disputes the facts and has appealed the MDH determination. The case is ongoing.

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between Licensee and the Board that:

1. During all times herein Licensee has been and is now subject to the jurisdiction of the Board, from which she holds a license to practice as an assisted living director.

2. Licensee must **CEASE AND DESIST** from the practice as an assisted living director in the State of Minnesota and from holding herself out as authorized as an assisted living director in the State of Minnesota until this Stipulation is modified or is rescinded.

3. The Board agrees not to initiate disciplinary action against Licensee while the above-referenced MDH matters are pending so long as Licensee complies with the agreements in this Stipulation. This Stipulation is not disciplinary action.

4. This Stipulation shall be in effect until: (a) the Board dismisses the complaint; (b) Licensee enters into a stipulation and order with the Board; or (c) the Board issues an order resolving the matter as authorized by law. Notwithstanding, Licensee may petition the Board for removal of this Stipulation upon proof that Licensee is able to practice as an assisted living director with reasonable skill and safety, in full compliance with the statutes and rules governing assisted living directors, with or without conditions, limitations, and restrictions on Licensee's practice. In addition, as part of the petition process, Licensee may be required to meet with the Board's Standards of Practice Committee.

5. Licensee's noncompliance with or violation of this Stipulation shall be considered a violation of Minnesota Rule 6400.7095, subpart 1(E) and shall constitute grounds for disciplinary action against Licensee's license.

6. Licensee shall notify the Board within 15 days of the disposition of each of the above-referenced MDH appeals.

7. Licensee agrees that should she violate the terms of this Stipulation, the following actions may be taken by the Board:

a. The Board may, pursuant to Minnesota Statutes Chapter 14 and Minnesota Rules 1400.5100 to 1400.8400, file a contested case at the Office of Administrative Hearings.

b. Licensee agrees that in a contested case about an alleged violation of this Stipulation, the administrative law judge might only be able to consider whether this Stipulation was violated. If the administrative law judge finds that there has been a violation, he or she may



make a recommendation that it is appropriate for the Board to take disciplinary action against Licensee's license.

c. Licensee agrees that, in the event the Board receives findings of the administrative law judge that there has been a violation of this Stipulation, the Board may order disciplinary action, including a suspension or revocation of Licensee's license to practice as an assisted living director.

d. Upon application of the Board, any appropriate court may enforce the terms of this Stipulation and prohibit Licensee's practice as an assisted living director until the conditions of this Stipulation are fulfilled.

8. This Stipulation shall be classified as public data for purposes of Minnesota Statutes sections 13.02, subdivision 15 and 13.41, subdivision 5. Data regarding this action will be provided to data banks as required by Federal law or consistent with Board policy.

9. Licensee is represented by Christine Chambers, Esq., of Arthur Chapman Kettering Smetak & Pikala, P.A, in Minneapolis, Minnesota. The Committee is represented by Alex Mountain, Assistant Attorney General.

10. Licensee acknowledges that she has read this Stipulation, understands the terms and conditions as set forth in it, and freely and voluntarily signs this Stipulation.

11. This Stipulation contains the entire agreement between the Board and Licensee, there being no agreement of any kind, verbal or otherwise, which varies this Stipulation.
