## Technician Continuing Education Reporting Due July 31, 2025

---

Technicians registered with the Minnesota Board of Pharmacy are required to complete 20 hours of continuing education (CE) every two years to maintain their active status. Continuing Education reporting is due by July 31st of every odd year. **If you are a newer registrant** your number of hours may differ. You can [log into your online account](#) to find out how many hours of CE are required.

The Continuing Education Courses that you take must be approved for technicians and be ACPE or Board approved, and completed between August 1, 2023 and July 31, 2025 for this CE cycle. [MN Board of Pharmacy Rule 6800.1500](#).

Please note:

- **Proof** of CEs will be required if you do not attest by July 31, 2025
  - Failure to complete the required number of hours will affect your ability to renew your registration.
  - Pharmacy technician registration renewals will open on October 1, 2025.
