1. Review and approve May 8, 2024, Meeting Minutes

2. Last Meeting Follow-up

- A. Positions & hiring status
 - Forensic Navigator Supervisor interviews are this afternoon and tomorrow morning. The Program Administrator requested approval to hire up to two supervisors if there are two strong candidates in the pool so that we can try to plan a bit for when we start hiring again in the fall. Board members agreed with this approach.

5. Other Business

A. HB4109 update

- This was the bill that had our name change provision in it. The language shifted to the
 omnibus bill and HB4109 was reused for another unrelated issue. Representative
 Edelson is moving into the Hennepin County Commissioner role and will be resigning
 from her legislative position.
- B. Review of FN program documents
 - Flyer for clients positive feedback, needs some design work, expand language to say more specifically what we can and cannot do
 - Notice of Assignment positive feedback
 - Bridge Plan positive feedback too, some suggestions include adding some information about the type of location upon release and possibly other info like the location.
- C. Questions from the Navigators
 - Are they considered mandated reporters?
 - Do they have immunity like GALs?
 - Board members has some discussion about both questions and recognized it needs further discussion and perhaps input from the AGs office (especially absent our own legal counsel).
