# 2. Board Chair Updates

- The Board chair reported that he has been meeting with each member to discuss the By Laws, perspectives on progress. He still has a couple of members to meet with.
- The By Laws should be ready for review at the October 9, 2024 meeting.
- He asked all members to think about other ideas for work the Board should consider in the future. Members were asked to keep a list of their ideas for a future discussion.

#### A. Case Data

- The Program Administrator shared that as the Compass implementation gets closer, we're looking more closely at the data and information we are currently collecting and what might need to be added in the future and we're seeking input from the Board members. - Ideas shared by Board members included a variety of information both qualitative and quantitative. Members noted that it would be good to revisit the goals for data collection, to assess and discuss what data should be MNCAB's responsibility to collect vs. what can/should be asked for from partners.
- MNCAB employees will organize the input from the Board and use it to shore up the data collected in Compass vs. other avenues and bring the ideas back to a future Board meeting for more discussion and planning.
- Members also noted that it's a good time to consider the hiring timeline for a data analyst/quality position.
