# **Agenda Items**

## 1. Call to Order

Pursuant to Minnesota Statutes section 13D.04, subdivision 2, the Minnesota Prescription Drug Affordability Advisory Council (PDAAC) called this special meeting for the purpose of convening and electing officers of the MN PDAAC and other general matters related to formation of the PDAAC.

The special meeting of the PDAAC convened Friday, June 14, 2024.

The PDAAC called the meeting to order at 1:00 PM and announced that a quorum was present.

## 2. Governance Structure

Ney noted that there are no statutory requirements for officers and that the constitution and responsibilities of officers are at the discretion of the PDAAC. Discussion of potential governance organization including Chair/Vice Chair, Co-Chairs, Secretary, and Interim Chair.

• Brown moved that the PDAAC create the position of Interim Chair of the PDAAC, without specific time limit or role. Motion seconded by Farley.

  - 3) report on the activities of the PDAAC to the PDAB.
