
Craft governing policies to guide behavior and decisions

By-laws are the foundational rules necessary to operate as a governing body.

A **policy** sets high-level expectations for behavior or results.

A **procedure** focuses on how to accomplish a policy, whether at the governing or administrative level.

Policy Development – set the administrative playing field

Ends policies

These policies define the external results the organization is to achieve, who the recipients of the results are, and how much the organization will extend in resources to secure those results.

There is no template for Ends policies. We will start from scratch (and your statutory requirements!) to develop your policies.

Executive Limitation policies

Theses policies define the constraints on executive authority that establish the prudence and ethical boundaries within which all executive activity and decisions must take place.

Plan for your policy development initiative

- Stacy produces draft policies in batches, sometimes with additional expert assistance.
- Drafts sent to policy development work group 2 weeks before board meeting for their individual review.
- Work group meets to finalize the policy batch before Vernon includes them in the board meeting packet.
- **Board members are** encouraged to review policy drafts prior to meeting and come to the meeting with clarifying questions.
- The work group leads board through review discussion.
- Individual Board members have 1 week following meeting to provide more specific feedback. Send feedback directly to Vernon.
- All policies will be approved in one batch in June.
- Policies will be activated starting July 1, 2026. Compliance monitoring commences at the following meeting.
