

## Weatherization Yog Dab Tsi?

Nws yog ib lub khoos kas pab cov tswv tsev thiab cov neeg xauj tsev uas khwv tau nyiaj tsawg nyob hauv Xeev Minnesota kom tau txais kev txhawb thiab kev pab cuam kev siv hluav taws xob kom tso tau lawv cov nuj nqis siv hluav taws mus tas li kom ntseeg tau tias tej vaj tse muaj kev nyab xeeb. Lub khoos kas tau txais kev tso cai los ntawm U.S. Thawj Feem Hauj Lwm Saib Xyuas Hlluav Taws Xob, uas tau txais kev tawm peev ntawm los ntawm U.S. Feem Tuav Hauj Lwm Muab Kev Pab Cuam Kev Noj Qab Haus Huv thiab Tib Neeg, thiab tau txais kev lis hauj lwm los ntawm Xeev Minnesota Thawj Feem Tuav Hauj Lwm Kev Khiav Lag Luam los koom tes nrog rau pab pawg neeg koom tuav hauj lwm ntawm 23 qhov chaw muab kev pab cuam rau zej zos.

### Nws muaj pub rau leej twg?

Minnesota's Weatherization Assistance Program yuav pab cov cuab yim neeg txog los sis qis dua 200% ntawm tsoom fwv cov ntawv coj qhia nyiaj khwv tau cov neeg txom nyem, uas yog tes dej num tseem ceeb uas muab rau cov cuab yim neeg uas muaj cov tswv cuab yog cov laus los sis xiam oob khab, cov me nyuam, los sis muaj kev siv hluav taws xob ntawm.

### Nws yuav pab kuv li cas?

Yog hais tias koj tsim nyog, ib lub chaw muab kev pab cuam hauv zos mam tuaj ua kev ntsuam xyuas kev siv hluav taws xov hauv vaj tse pub dawb txhawm rau txheeb xyuas cov kev txhim kho qhov nqi them kom muaj hluav taws xob txaus siv uas tuaj yeem yuav ua kom tiav rau hauv koj lub vaj tse. Weatherization cov kev pab cuam tuaj yeem pab txo koj cov nuj nqis siv hluav taws xob txhua xyoo txog li ntawm 30%. Cov kev txhim kho kev siv hluav taws xob kom zoo tuaj uas yuav muaj pub suav nrog:

- Txo kev to dim pa
- Kev txhaws thaiv ru tsev thiab phab ntsa tsev sab nrauv
- Kev kho qhov cub, cuab yeej hau khoom, thiab taub rhaub dej kub los sis kev hloov kho
- Lub ntsuas cua kub tshiab uas hloov kho tau
- Cov tuav kev ceeb toom pa taws thiab cov ntsuas carbon monoxide

### Kuv yuav rau npe thov siv cov kev pab cuam no li cas?

Cov Neeg Pej Xeem Minnesota tuaj yeem rau npe thov siv kev pab ntawm khoos kas pab huab cua rau vaj tse los ntawm daim ntawv rau npe thov uas sau ua ke nrog rau lub lav lub khoos kas Energy Assistance Program (lub uas pab cov tswv tsev thiab cov neeg xauj tsev them nqi rau cov nuj nqis tso cua kub).
