Meeting Notes

Report from Workgroup-Objectives 7 and 9

- I. Suggested letting people return to the forensic mental health program for up to 6 months if they have medical needs and no other place to go
- II. Suggested extending voluntary return timelines from 60 days to 90 days
- III. Recommended updating legal language to use "Forensic Mental Health Program" instead of "Minnesota Security Hospital"
- IV. No agreement has been reached on:
 - a. Changing the law to exclude people with disabilities or brain injuries
 - b. Changing deadlines for treatment plans
 - c. Changing wording in the law about being "ready for the community

Report from Workgroup-Objectives 3 and 4

- I. Suggested using forensic navigators to help people find services and placements
- II. Proposed using the competency process (statute 611) before making final MI&D commitments
- III. Not enough treatment options or support in jails
- IV. More time is needed to understand how these changes would work

Open Discussion for all Workgroup Members

- I. Many members said more resources are needed:
 - a. Crisis and step-down programs
 - b. Better-trained and better-paid staff
 - c. Safer and more appropriate housing options
- II. Data shared:
 - a. 13% of people in the MI&D program may not meet full criteria
 - b. Some have been in the system for decades
 - c. Very few return to the program due to new crimes
- III. Next steps:
 - a. Workgroups will continue drafting changes
 - b. More meetings may be added to finish the work and prepare the final report
