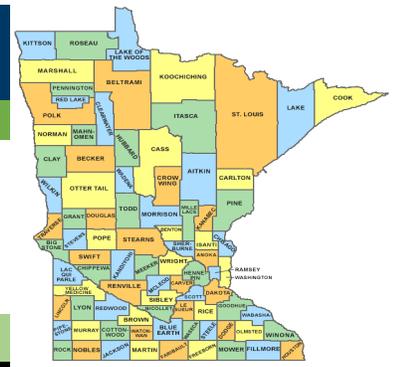


COUNTY PROFILE

Freeborn Co.

Freeborn Co. is a part of Economic Development Region 10, which is located in the Southeast Planning Region.



POPULATION CHARACTERISTICS


Freeborn Co.'s population has decreased so far this decade, ranking as the 65th fastest growing of the 87 counties in the state from 2010 to 2019. It is now the 35th largest in the state. Freeborn Co.'s population has an older median age than the state and a larger percentage of people aged 65 years and older. The population is aging, especially as the Baby Boom generation moves through the population pyramid (see Figure 1).

Freeborn Co. suffered a negative natural increase - more deaths than births from 2010 to 2019, but also experienced net out-migration - meaning more people moved out than moved in. Despite suffering domestic out-migration, Freeborn Co. welcomed net international in-migration - gaining new Minnesotans from foreign countries (see Table 2).





POPULATION PROJECTIONS


According to the Minnesota State Demographic Center, Freeborn Co.'s population is expected to decline from 2020 to 2030, with a rate of change that is slower than the projected statewide growth rate (5.0%). Despite the decline, the number of people aged 65 years and older is expected to increase over the next decade (see Figure 4 and Table 5).

EDUCATIONAL ATTAINMENT

Freeborn Co. has a lower percentage of adults (18 years & over) with at least a high school diploma than the state (92.4%), and a lower percentage of people with at least some college experience. Freeborn Co. also has a higher percentage of people with an Associate's degree and a lower percentage of people with a Bachelor's degree or higher.



Figure 5. Educational Attainment, 2018





LABOR FORCE TRENDS


Figure 6. Annual Labor Force Estimates

The number of workers in Freeborn Co. increased over the past year. Long term, Freeborn Co.'s labor force declined more slowly from 2004 to 2019, compared to a statewide growth rate of 8.0% (see Figure 6).

At 3.5%, Freeborn Co. had a higher unemployment rate than the state in 2019. Freeborn Co.'s unemployment rate increased compared to 3.2% in 2018, and was lower than the 8.4% rate posted in 2009. The number of unemployed workers actively seeking work in Freeborn Co. increased over the past year, and is down compared to 2009.


Labor force growth has slowed in recent years. After experiencing a net gain of workers from 1990 to 2000, Freeborn Co. averaged an annual loss of fewer workers from 2000 to 2010, and most recently a loss of fewer workers since 2010 (see Figure 7). Moving forward, Freeborn Co. is expected to see a labor force decline from 2020 to 2030 (see Table 6).

Freeborn Co. is a part of Region 10, which includes Dodge, Fillmore, Freeborn, Goodhue, Houston, Mower, Olmsted, Rice, Steele, Wabasha, and Winona County. The labor market has grown extremely tight in recent years, dropping to a ratio of 0.7 jobseekers per vacancy during the 4th quarter of 2019 (see Figure 8).


LABOR FORCE CHARACTERISTICS

Freeborn Co. had a lower labor force participation rate than the state. The labor force in Freeborn Co. is less racially diverse than the state (where 85.5% of workers are white alone), but is becoming more diverse over time.

Figure 9. Labor Force by Race, 2018






INCOMES, COST OF LIVING, & HOUSING

Freeborn Co. also had a lower cost of living than the state, with a required hourly wage of \$12.63 for a single person living alone to meet a basic needs cost of living, and an hourly wage requirement of \$14.78 for a typical family with 2 adults and 1 child (see Table 9).





OCCUPATIONS

At \$19.89 in 2020, wages were lower in Region 10 than the state. Overall, Region 10 had the 3rd highest median hourly wage level of the 13 economic development regions in the state. Wages were highest for management occupations (\$43.33) and lowest for food preparation and serving related jobs (\$12.1) (see Table 11).


JOB VACANCY SURVEY

Freeborn Co. is a part of Region 10, which includes Dodge, Fillmore, Freeborn, Goodhue, Houston, Mower, Olmsted, Rice, Steele, Wabasha, and Winona County. There were 10599 job vacancies posted by employers in the 4th Quarter of 2019, indicating extensive opportunity in the region, with openings across several occupations and industries (see Figure 14).

ECONOMIC CHARACTERISTICS

After gaining jobs over the past year, Freeborn Co. had the 35th largest economy of the 87 counties in the state. Freeborn Co. was the 36th fastest growing in the past year and the 60th fastest growing since 2014. From 2014 to 2019, employers in Freeborn Co. cut jobs, but lagged the state's 6.3% growth rate.




