In accordance with Minn. Stat. § 214.035, subd. 4, the Department of Commerce reports the following data:

- 72,714 individuals applied for a professional or occupational license, registration, or certificate from the Department of Commerce during calendar year 2024.
- Of those, 10 were found to be ineligible due to a criminal record or conviction.
- 16 individuals submitted a preliminary application under Minn. Stat. § 214.035.
- Of those, 5 were found to be ineligible due to a criminal record or conviction; 4 applications are still pending.
