Introduction

The federal <u>Clean Water Act</u> (CWA) authorizes the U.S. Environmental Protection Agency (EPA) <u>Clean Water</u> <u>State Revolving Fund program</u> to provide funds to states to finance a wide range of water quality infrastructure projects. The CWA authorizes EPA to award capitalization grants to each state to capitalize a state revolving fund which the state can use to provide loans and other assistance to water pollution control projects.

Minnesota Statutes, section 446A.07 authorizes the Minnesota Public Facilities Authority (MPFA) to establish the state's Clean Water State Revolving Fund (CWSRF) and manage it to be available in perpetuity for low-cost financing of water infrastructure. As part of its capitalization grant application requirements, MPFA annually prepares a CWSRF Intended Use Plan (CWSRF IUP or IUP) describing the intended uses of available funds.

To be eligible for placement on the CWSRF IUP:

- 1. The project must be listed on the <u>Clean Water Project Priority List</u> (PPL) maintained by the Minnesota Pollution Control Agency (MPCA) as provided in <u>Minnesota Rules</u>, <u>part 7077.0115</u>. PPL rankings give funding <u>priority</u> to projects that address water quality needs. PPL rankings focus on environmental and public health factors related to water quality and climate resiliency.
- 2. The applicant must submit a written request to MPFA for placement on the CWSRF IUP that includes a brief project description, estimated cost and requested funding, and a project schedule indicating the project will proceed in the state fiscal year (SFY) for which the CWSRF IUP is being prepared.

This IUP lists projects from the 2026 PPL (see Exhibits 3 and 4) and supporting activities MPFA intends to fund in SFY 2026 (July 1, 2025 through June 30, 2026), plus those projects that have requested placement on the CWSRF IUP but rank below the fundable range. The projects are grouped in PPL priority order by these parts:

Part A	Fundable range	Carryover: projects in the fundable range on the prior year's IUP certified by MPCA by June 30, 2025 and meeting application requirements.
Part B	Fundable range	New: eligible projects not certified by June 30, 2025 and ranked at or above the cutoff
Part C-1	Non fundable range	Below the Fundable Range: eligible projects not certified by June 30, 2025 and ranked below the cutoff
Part C-2	Non fundable range	The 2026 IUP requests for these projects were withdrawn.

MPFA will apply for EPA base capitalization grants and Infrastructure Investment and Jobs Act (IIJA) General Supplemental and Emerging Contaminants (EC) grants. The FFY 2025 EC grant will be transferred to the Drinking Water State Revolving Fund. MPFA will use a combination of these federal funds, other CWSRF fund assets, and state appropriations to implement this IUP. This IUP includes sufficient projects to utilize the base and IIJA grant funds, and state match appropriations.

This IUP establishes the fundable range for CWSRF projects, sets the base loan discount for the CWSRF, and sets percentages to be reserved from federal grants for eligible set-aside activities.

There is sufficient funding for Part A and B requests.

See the section <u>IUP Fundable Range Progression Process</u> for a description of MPFA's IUP amendment process to add additional projects to the fundable range.

The base discount for CWSRF loans will be: 1.000% for loans up to \$92 million, with no base discount applied to loan amounts more than \$92 million.

Background

The MPFA <u>board</u> (Board) consists of six state commissioners representing the departments of Employment and Economic Development (DEED) as chair, Management and Budget, Health (MDH), Agriculture, Transportation, and MPCA. MPFA provides financing and technical assistance to local governments for wastewater, stormwater, drinking water, and transportation infrastructure projects to enhance the environmental and economic vitality of the state.

MPFA receives federal capitalization grants and state matching funds to capitalize its SRFs and has statutory authority to carry up to \$2 billion in outstanding revenue bonds. MPFA CW and DW SRF bonds are rated AAA by all three rating agencies. Bonds are repaid from loan repayments and investment earnings (no state backing). At June 30, 2025, total MPFA assets and liabilities included:

- Current loans outstanding: \$1.9 billion.
- Total assets: \$2.5 billion.
- Current bonds outstanding (par): \$573 million.

MPFA's CWSRF and Drinking Water State Revolving Funds (DWSRF) combine annual federal capitalization grants and state matching funds with loan repayments and MPFA revenue bond proceeds to provide a permanent source of low-cost capital to help local governments finance wastewater, stormwater, and drinking water infrastructure projects. Projected sustainable annual lending capacity for the two funds:

- CWSRF: \$184 million per year.
- DWSRF: \$ 64 million per year.

MPCA and MDH PPLs rank projects based on public health and water quality criteria. Cities request placement on the annual IUPs when projects are ready to proceed with construction. MPFA provides project financing to cities of all sizes with below-market rate loans available to all projects in the fundable range of the IUPs, and targeted grants based on affordability and specific project types. Within this collaborative structure:

- MPCA prioritizes projects, conducts technical and environmental reviews, issues permits and certifies projects for MPFA funding.
- MPFA conducts application and credit reviews, sets loan terms and conditions, service loans, coordinate funding from other sources, and provide overall fund management and program administration.
- Staff from each agency help local governments understand the funding processes, program requirements, and local responsibilities.

MPFA priorities are to:

- Provide financing programs supporting public health, water quality, environmental protection and other priorities as identified by MPFA member agencies.
- Help local governments maintain and improve the condition of their infrastructure assets while keeping rates affordable for their residents.
- Manage revolving fund assets to be state sources for infrastructure financing in perpetuity.

MPFA makes below-market rate loans and grants available to finance infrastructure that might otherwise be unaffordable to communities if they had to borrow money at market rates. Project timing and other considerations determine which source(s) of funds are used for each project. MPFA details actual sources in its annual reports to the EPA.

Goals and Financial Status of the CWSRF

CWSRF Goals

MPFA commits to using the CWSRF effectively to help ensure safe and reliable drinking water to all Minnesotans. Federal, state, local, and private resources will be used to meet short-term and long-term goals.

The Annual Project Solicitation Process

Each year in January the three SRF agencies (MPCA, MDH, MPFA) launch the cycle to solicit projects for ranking on the PPLs and IUPs with a coordinated GovDelivery communication, website postings, and industry newsletters. This notice outlines due dates for project proposals and technical project requirements.

The three agencies host and participate in training events and finance schools across the state to help communities prepare their PPL and IUP requests and to present and discuss application and program requirements.

CWSRF Project Priority List

The PPL prepared by MPCA identifies wastewater and stormwater infrastructure projects that are potentially eligible to receive CWSRF financing over the next five years. Projects are ranked based on the priority point system established in Minnesota Rules, parts 7077.0115 to 7077.0121. The 2026 PPL contains 353 projects with total estimated costs of \$4,257,879,990. See Exhibit 3 for the PPL in priority order and Exhibit 4 for the PPL in alphabetical order.

MPCA rules governing clean water priority points criteria focus on environmental and public health factors. The PPL scoring criteria for National Pollutant Discharge Elimination System wastewater projects emphasize age and condition of existing infrastructure, excessive inflow and infiltration, and repeated failures including bypass and sanitary sewer overflow events. Stormwater project scoring encourages green infrastructure in areas with high impervious surface ratio as a proxy for pollutant loading, volume reduction/infiltration, and encouraging multiple environmental benefits. Clean Water projects incorporate the latest technical design standards (including Ten State Standards). The facilities planning process includes a cost and effectiveness project review which considers the potential for efficient water use, reuse, recapture, and conservation, as well as energy conservation.

CWSRF IUP Development

MPFA prepares the IUP in accordance with <u>Minnesota Statutes</u>, <u>section 446A.07</u>, <u>subdivision 4</u> and <u>Minnesota Rules</u>, <u>part 7380.0422</u>. The IUP fundable ranges identify projects from the PPL eligible to apply for and receive funding through the CWSRF in SFY 2026.

Each project in the fundable range requires a complete funding application and MPCA project certification under the provisions of Minnesota Rules, parts 7077.0280 to 7077.0281 before CWSRF funding can be approved.

The IUP lists projects in priority order as ranked by MPCA on the PPL. Applicants request inclusion on the IUP in writing to MPFA. To ensure MPCA has adequate time to review projects before the June 30 preliminary approval deadline, applicants must submit wastewater facility plans or stormwater project plans to MPCA within 6 months from the date MPFA approves the IUP. MPCA posts PPL instructions, application forms, and general program information online.

The approved IUP remains in effect until the following year's IUP is approved. If an unawarded project listed in the IUP fundable range has an active funding application underway and has been certified by MPCA by June 30, 2026, then that project will be carried over to the fundable range on the 2027 IUP.

IUP Fundable Range Progression Process

Per statute, MPFA may amend the CWSRF IUP to include additional eligible projects proposed by MPCA. This would be an administrative amendment as part of SRF fund management to help ensure effective use of available funds to target eligible, priority projects that are ready to proceed. A project may be added to the fundable range, from Part C of the IUP or from the PPL, under these conditions:

- 1. MPCA recommends the project to MPFA based on these considerations:
 - a. The project addresses a documented environmental or public health threat, **OR**
 - b. The project is proceeding concurrently with a project in the fundable range on the CWSRF or DWSRF IUP, **OR**
 - c. The project would help meet capitalization grant agreement requirements.

AND:

- d. Plans and specifications have been submitted to MPCA (deadline is 6 months after IUP adoption, but by March 31, 2026 if possible please), **AND**
- e. Facility plan has preliminary approval, AND
- f. A draft project application has been accepted by MPFA.

- 2. MPFA determines that funds are available based on these considerations:
 - a. There are sufficient projects in the IUP fundable range that have not met the application or plans and specifications deadlines, **AND/OR**
 - b. Sufficient additional capitalization grants, state match, or other SRF assets have been added to available project funds since the original IUP approval.
- 3. MPFA determines project readiness to proceed based on these factors:
 - a. The project has been certified by MPCA, AND
 - b. Construction bids, as applicable, have been awarded, AND
 - c. MPFA has approved the completed project application.

NOTE: if not all the requirements under 3 have yet been met then MPFA will send a funding assurance letter to the applicant giving MPFA's pledge that the project will be added to the CWSRF IUP fundable range IF these requirements are met prior to adoption of the next year's IUP. If the requirements are not all met by then, the project will be included on the next year's IUP, but only as a carryover project if certified by June 30, 2026.

4. MPFA adds the project to the IUP fundable range and proceeds with the financing agreement.

These IUP amendments will be administrative in nature.

Public Comment

MPFA Board action establishes the public comment period for the draft IUP. The IUP is considered final upon consideration and incorporation of comments received during the public comment period. MPFA notices the comment period via GovDelivery and on its website. MPFA accepts written comments via email. Comments are reviewed by MPFA and MPFA staff. The final IUP notes responses and MPFA provides individual written responses as warranted.

By statute, MPFA offers eligible recipients seeking placement on the CWSRF IUP an opportunity to review and comment on the plan before it is adopted. The draft plan may be changed to add additional projects based upon funding availability and project readiness.

In reviewing comments received, MPFA considers a) whether a comment is within scope of the IUP, b) if the proposed project or use of funding is eligible for CWSRF funding or c) if the project start date is after June 30, 2026.

Financial Management and Official Controls

Capacity Model

Projected sustainable lending capacity is updated at least annually, based on existing assets and debt obligations, predicted market rates and subsidy levels, additional capital contributions, and current year lending levels. These are rough estimates of sustainable capacity, which will be affected by actual market rates, subsidy levels and contribution amounts from federal capitalization grants and state match. MPFA considers this analysis when setting the fundable range for IUPs annually.

Sources and Uses

Exhibit 2 shows the sources and uses of funds in the CWSRF for SFY 2025, the total amounts from inception through SFY 2025, and the estimated amounts for SFY 2026. Demand for CWSRF financing continues to grow. MPFA manages excess demand by setting a fundable range for new project requests based upon PPL priority points, and by setting a cap on the annual loan amounts to any system that will be eligible for the base discount.

Transfers

MPFA retains flexibility to transfer capitalization grants and other funds held or allocable to such funds as permitted under 40 CFR 35.3555(c)(8) between the DWSRF and the CWSRF. This IUP reflects an anticipated \$3,909,000.00 transfer from the FFY 2025 CW EC capitalization grant to the DWSRF for drinking water EC projects.

Loan Terms and Conditions

MPFA determines terms and conditions for CWSRF loans pursuant to Minnesota Statutes, section 446A.07 and Minnesota Rules, part 7380.0430. Loans are not awarded until as-bid costs are submitted to MPFA. MPFA makes CWSRF loans at below-market rates in accordance with federal and state law. The standard loan term is 20-years or up to 30 years for projects meeting disadvantaged community criteria describe below. No loan term can exceed the useful life of the project.

To manage large project requests within the CWSRF annual lending capacity, MPFA may provide separate financing agreements over more than one year based on the project's cash flow needs as negotiated between MPFA and the borrower.

Interest Rates

The basis for setting interest rates is described in Minnesota Rules, parts 7380.0442-0445. MPFA bases interest rates on the greater of the current bond market rates for AAA or AA rated municipal bonds as determined by a daily index, (or the bond yield scale of MPFA's bonds if MPFA bond proceeds are available) less any discounts described below. MPFA deposits up to 2% of the interest portion of each repayment into an administrative fee account outside the SRF to pay program administrative expenses. This is not an additional charge to the borrowers.

Additional discounts up to 2.0% may be applied to borrowers under 2,500 population as described in Minnesota Rules, part 7380.0442, subpart 3B. These discounts take project affordability into account. The minimum interest rate under MPFA rules is 1.0%. Interest rates are at or below market rates in accordance with federal and state law.

Cross-Collateralization

Since 1997, MPFA has cross-collateralized bonds sold for the DWSRF and CWSRF programs to enhance bondholder security. This improves the bond's credit rating and reduces the interest rates, allowing MPFA to offer better interest rates to its SRF borrowers.

Subsidization

Federal capitalization grants require states to use certain percentages of the federal funds for additional subsidization beyond below-market interest rates for projects meeting specific criteria. Base capitalization grants require a minimum of 10% and a maximum of 20% to be used for additional subsidization. IIJA Supplemental grants require 49% to be used for additional subsidization. IIJA EC capitalization grants require 100% to be used for additional subsidization.

MPFA provides additional subsidization to eligible projects in the form of principal forgiveness (PF) grants, meaning a reduction in the amount of loan principal that must be repaid, which is granted when MPFA awards a CWSRF financing agreement. MPFA awards PF grants to address affordability in disadvantaged communities and for projects that address emerging contaminants, and for Green Project Reserve projects.

Disadvantaged Community and Affordability Criteria

Minnesota Statutes, section 446A.07, subdivision 8(b), authorizes CW PF grants 1) based on the criteria and requirements established for water projects under section 446A.072. The Water Infrastructure Funding Program (WIF); 2) for 25 percent of project costs up to a maximum of \$1,000,000 for Green Project Reserve projects to address green infrastructure, water or energy efficiency improvements, or other environmentally innovative activities; and 3) for 50 percent of project costs up to a maximum of \$3,000,000 for projects that address emerging contaminants as defined by the EPA. A CWSRF project may receive a WIF or CWSRF PF grant in conjunction with a CWSRF loan when the average per household system cost exceeds 1.4% of median household income. The maximum grant may not exceed \$10 million or \$20,000 per existing connection, whichever is less. WIF assistance is for project costs necessary to existing needs, not growth. Eligible project cost is determined by multiplying the total project cost by the essential project component percentage calculated by MPCA. Projects qualifying for PF or WIF cannot be determined based solely on information provided in the IUP request. MPFA uses additional project information submitted during the application phase, including details on system users and system costs, debt, and as-bid costs to calculate the cost impact to system users.

Affordability and Non-SRF Programs, Federal

USDA Rural Development (USDA RD)

Small rural communities under 10,000 population with median household incomes below the non-metro state average may apply to USDA RD for wastewater and drinking water grants and loans. RD grant funds are restricted to communities with median household incomes below the non-metro average. Projects eligible to receive USDA RD grants based on the USDA RD affordability criteria may receive WIF matching grants from MPFA for up to 65% of the total grant need as determined by the USDA RD. This state-federal partnership allows state WIF funds to assist more projects, makes it easier for small communities to access funding, reduces state administrative expenses, and helps USDA RD maximize federal funding available for Minnesota communities.

EPA

Federal PF funds come from a portion of the annual federal funding for the state revolving loan programs and have significantly increased with funding from the IIJA. Federal law provides that PF funds may be awarded as grants to reduce project costs that would otherwise be included in loan principal. Under state statutes, federal PF grants may be awarded based on the same affordability criteria as WIF grants. State statutes authorize PF grants for green infrastructure projects and other specified project types.

MPFA considers unemployment data as a secondary factor after the WIF criteria for federal PF funds. To the extent possible, MPFA directs federal PFs funds to eligible projects whose county unemployment rate is higher than the state's unemployment rate.

MPFA uses additional project information submitted during the application phase, including details on system users and system costs, debt, and as-bid costs to calculate the cost impact to system users and whether projects qualify for PF or WIF.

Green Project Reserve (GPR)

Federal PF funds in the base and IIJA supplemental capitalization grants may be granted to point source projects that address green infrastructure, water or energy efficiency improvements, or other environmentally innovative activities, including activities to mitigate stormwater runoff and enhance sustainability, per Section 603 (i)(2) of the Clean Water Act. Under Minnesota Statutes, Section 446A.07, Subdivision 8, paragraph (8), the GPR PF amount is limited to 25 percent of the eligible CWSRF project cost as determined by MPCA, up to a maximum of \$1,000,000. MPCA verifies GPR eligibility during the plan and specification review process.

Affordability and Non-SRF Programs, State

Small Community Development Program (DEED)

The <u>Small Community Development Program (SCDP)</u> provides Community Development Block Grant (CDBG) funding through the US Department of Housing and Urban Development (HUD) to qualifying non-entitlement communities for public infrastructure projects often in conjunction with MPFA, USDA Rural Development, MPCA and MDH to make rural communities more viable.

Department of Iron Range Resources and Rehabilitation Board (IRRRB)

The <u>IRRRB</u> provides public works grants for infrastructure to local governments with maximum awards of \$1.5 million per SFY. Publicly-owned projects in cities located near an active mine pit or a mine pit that has been idled within the last two years are eligible.

Equivalency

MPFA designates projects in amounts equal to each capitalization grant as federal equivalency projects.

The CWSRF contains funding from federal capitalization grants, state match, MPFA revenue bond proceeds, loan repayments, and investment interest. Equivalency provides a way of identifying projects that must meet the additional federal equivalency requirements regardless of funding sources used.

MPFA and MPCA will strive to 1) minimize the number of CWSRF projects that must comply with the additional equivalency requirements and 2) identify these projects as early as possible in the project life cycle.

Projects in this IUP's fundable ranges will be identified for equivalency as "Yes", "No", or "To be determined (Tbd)" to retain the flexibility, as projects move forward, to ensure that the number of equivalency projects is minimized while meeting each capitalization grant's requirements.

MPFA may designate more projects as equivalency to remedy a prior year deficit. MPFA will report the final list of equivalency assistance agreements in its annual reports to the EPA and monthly through SAM.gov to comply with Federal Funding Accountability and Transparency Act requirements.

Funding Sources

2025 Minnesota state legislature language changes related to MPFA programs:

The statutory caps for grant awards were raised from \$5 million to \$10 million for WIF and from \$7 million to \$12 million for PSIG to better address higher project costs driven by inflation and increased project complexity and scope.

Added principal forgiveness or grants for 50 percent of project costs up to a maximum of \$3,000,000 for projects addressing ECs as defined by EPA.

Also, the legislature approved an increase to MDH's safe drinking water fee (aka public water supply fee) from \$9.72 to \$15.22 per water service connection, effective January 1, 2026. Per MDH this will restore some funding to the DWSRF for drinking water infrastructure projects.

Federal Funding

MPFA applies for federal funds upon notification by EPA of available funding levels. In general, factors impacting timing of funding applications may include availability of state match appropriations, and notice from EPA on final funding allocations. MPFA is poised to apply for FFY 25 Federal Base Capitalization Grant, FFY25 IIJA General Supplemental, FFY 25 IIJA EC Grant, FFY25 IIJA LSLR, FFY 24 IIJA EC (including CWSRF EC Transfer).

Set-asides

Set-asides support the mission of the SRFs to support capacity building, asset management, and program administration by MPFA and MPCA.

Program Administration

MPFA reserves the authority to use up to 4% of base capitalization, IIJA base, and supplemental capitalization grants for program administration, which may include staff and improving on CWSRF tools. Any amounts not utilized under this IUP will be reserved for potential future program administrative activities.

Technical Assistance

The set-aside funding supports outreach and technical assistance to small, rural, or tribal wastewater facilities focusing on permitting support, financial assistance guidance, pollutant identification and reduction, building technical, managerial, and financial (TMF) capacity, technical evaluation of facility operations, optimization, infrastructure resiliency, and energy efficiency solutions. MPCA details technical assistance activities in work plans submitted to EPA with the associated capitalization grant applications.

Technical Assistance Funding

Amendments to the CWA enacted in IIJA permits states to set-aside a percentage of capitalization grant funds for certain non-project activities. Up to two percent (2%) of each capitalization grant can be set-aside for technical assistance for small, rural, and tribal publicly owned treatment works. EPA defines small and rural publicly-owned treatment works as systems serving populations of 10,000 or less or facilities treating less than 1 million gallons per day.

MPCA utilizes the Clean Water 2% technical assistance authority under the CWSRF Base grants to provide technical assistance activities to small, rural, and tribal publicly owned treatment works (POTWs). Two staff hired by MPCA provide outreach compliance support to small, rural, and tribal POTWs. MPCA contracts with Minnesota Rural Water Association (MRWA) for asset management assistance, technical training, and other outreach activities for small, rural, and tribal POTWs. The MPCA workplan and budget of \$835,980 is within the 2% authorized under IIJA.

Interagency Coordination

The three SRF agencies (MDH, MPCA, MPFA) coordinate activities related to outreach, training, technical assistance (TA), and asset management. Outreach and training events build awareness of the various funding programs, provide a general overview of those programs, and outline the financial and technical requirements associated with each program. These events take place throughout the year at water operator schools, training sessions, conferences, and workshops organized by our water industry partners, like Minnesota American Water Works Association, MRWA, and many others. TA activities, including asset management planning, are coordinated between MDH, MPCA, and our technical assistance provider, MRWA. These activities vary from direct on-site technical assistance to development of individual asset management plans. As an Example, in SFY 2025, the coordination between MPFA, MPCA and MRWA resulted in five completed asset management plans for five small municipal water and wastewater systems. MPFA provides more information on these efforts in the annual reports to the EPA.

Amending this IUP

MPFA may solicit public comments for substantive amendments to adopted IUPs. MPFA may administratively amend the IUP to add projects to the fundable ranges or to adjust for acceptance of additional state or federal funds.

Once adopted, an IUP remains in effect, as amended, until the next year's IUP is adopted.
