Dear Mr. Wadell, Mr. Varilek, Mr. LeMieur, and Mayor Zylka:

We are writing to inform you that Wabash National Services LP and Wabash National LP (together “Wabash”) will be conducting layoffs as a result of idling manufacturing operations at its facility located at 700 Paul Larson Memorial Drive, Little Falls, MN, 56345. Eventually, all manufacturing operations at this facility will cease. This employment action is expected to be permanent.

The first employee separations in connection with this action are expected to occur during the 14-day period starting on March 6, 2026. Enclosed is a listing of the job titles of the positions to be affected by this action, the number of affected employees in each job title, and their anticipated separation dates.

The affected employees do not have any bumping rights.

The affected employees are not represented by any union.
