- Quarterly Reports; next report due July 30th for Apr-Jun 2025 quarter
 - Submitting a progress report each quarter is a requirement of your contract with DEED. Per
 State of Minnesota's Office of Grants Management policy 08-09 "Grant payments shall not be

made on grants with past due progress reports unless the state agency has given the grantee a written extension."

- Contracts Being Extended Reminder
 - For any contracts receiving an extension, please remember that any MOUs or contracts you hold with partners/subgrantees will also need to be extended. MOUs and contracts must be valid for the full duration of your contract with DEED or for the duration of the service the partner is providing. If an MOU/contract is revised, please send an updated version to your ACP Program Coordinator.
- Electronic Document Storage (Jenilee)
 - Effective July 1, 2025, all local state and federal Employment and Training Program Partners
 must transition from paper (hard) copy participant files to maintaining electronic participant
 records using Workforce One (WF1, which includes the upload of all required participant source
 documentation (including all participant eligibility documents, employment plans, and support
 services documentation) into Electronic Document Storage (EDS) also known as Document
 Summary within WF1.Performance/Outcomes
- Performance Outcomes (7/1/2023-6/30/2025) Adult SS, Getting to Work, On Ramp, Bridge, ITP, SEA, WESA.
 - Be sure you are keeping up with your WF1 data entry!
 - Moving into the last months of the grant cycles, Grantees should focus on graduating participants, employment placements, and retention services.
 - Past performance and contract outcome progress will be taken into consideration as we move into the new legislative session (EX: participants enrolled, participants completing training, exits to employment, etc.).
 - Demonstrate report used for quarterly reporting (Jenilee)
 - Report Card Demonstration (Vanessa)

- ❖ 5 Common Compliance issues identified during monitoring (Jenilee)
 - Missing or no monthly participant case notes
 - No WF1 data entry (participants missing from WF1)
 - Lack of fiscal policies and procedures
 - Lack of subgrantee/subrecipient contracts
 - Disallowance of support services issued prior to enrollment or following exit
