Data Observations

- Participant activities are being tracked accurately.
- Exiting to employment is the primary focus of Adult Career Pathways programs.
 Performance data indicates overall 26% have obtained employment at their exit from an ACP program.
 - Are participants being trained for jobs with openings?
 - Are participants exiting from the programs accurately reflected in WF1?
 - Have participants received retention services and support to maintain employment through exit?
 - Engaged employer partners that build relationships with participants and hire graduate throughout duration of program.
- When is Completed Program Objective exit reason, correct?
- Running reports and reviewing them for accuracy on a regular basis is extremely
 important to accurate reporting in WF1. When Grantees are submitting quarterly reports,
 that is a good time to double check the data is being entered correctly.
