

CLIMB Desk Reference

Converting Layoffs Into Minnesota Businesses (CLIMB) is a set of allowable activities within the Dislocated Worker (DW) program to assist participants interested in starting or growing a business.

Eligibi	lity and Enrollment
	Individual is enrolled in DW
	The IEP reflects CLIMB goals
	The individual has completed required steps to be enrolled in CLIMB
	Case Notes include conversations/decisions about CLIMB
	Case Notes include progress towards goals (Completing business plan, training, connecting with business service programs, etc.)
Fundi	ng
	The participant has been informed that CLIMB does not provide grant or loans to directly benefit the participant's business in any way.
	The participant has been informed of training available through State DW program
	The participant has been informed of consulting available through State DW/community program
	The participant has been referred to the appropriate organization to learn about business funding strategies, opportunities, etc.
	The participant has contacted business service programs for further assistance
Unem	ployment Insurance (UI) Benefits
	The participant has received communication from UI
	The participant has followed up UI (paperwork)
	Earnings from business (does not impact UI)
	Earnings outside of business (must be reported and may impact UI)
	The participant was provided severance benefits through their employer (UI will not contact a participant until they have run out)
Perfor	mance and Data Validation
	EC must maintain contact every 30 days with participant
	EC must capture any credentials and/or Measurable Skills Gains (MSGs) from any paid CLIMB trainings
	Performance measures for CLIMB participants are measured at the state level
	If participant chooses to leave CLIMB and look for unsubsidized employment, update IEP with changed goals and close all CLIMB activities with the status of "Unsuccessful" and open a new job search activity.
Exit fr	om CLIMB
	If participant is making a livable wage in self-employment, close all CLIMB activities as "Successful"

and exit the participant with the exit reason of "Started Business/Self-Employed."



☐ If participant pursues and accepts unsubsidized employment, they should be exited from all CLIMB activities as "Unsuccessful" and exit with the status as "Entered Unsubsidized Employment." Do not open a new job search activity.

Employment Verification after Exit: Supplemental Wage Collection

After exiting the participant from the DW program, the counselor must verify the participant's selfemployment by documenting one or more of the following in the participant's case file for each of the four quarters after the exiting quarter:

IRS Form 1040-ES
1099 Tax form (for proof of contracted wages)
A list of individuals with whom the participant does business (names, addresses, phone numbers)
A list of companies or individuals from whom they purchase supplies or services (names, addresses phone numbers)
Advertising materials the participant used to market their products or services.

The state reserves the right to call customers and vendors to substantiate that the participant was working during each of the three quarters. Enter here
