DWFAP is publishing a Policy and Advisories Posting Schedule to better sync internal and external stakeholder calendars. This includes syncing policy and advisory posting dates as close as possible to applicable Workforce One (WF1) updates.

6. DWFAP Policy and Advisories Posting Schedule

Posting Dates will typically be the second and fourth Fridays of every month. If the second or fourth Friday falls on a [Minnesota State Holiday](#) then the Posting Date is moved to the next business day.

Note that not every Posting Date will have a policy or advisory published. DWFAP may also publish urgently needed policies or advisories at any time as needed, separate from the Posting Schedule listed below.
