

- Fulfill regulatory requirements for providing a labor exchange





CareerForce.MN.gov sprint review

What is a sprint review?

- A demonstration of the work that the product team has completed over a specific period
 - This can include new features, bug fixes, and changes to how the product (in this case, CareerForce.MN.gov) functions
 - A time to ask questions and give feedback to the product team



What we accomplished: Sprint 149

User accounts (deployed to test site):

- ✓ Updated administrative views of user profile pages
- ✓ Added styling and additional updates to Add Profile and Edit Profile pages of staff accounts
- ✓ Added “Back to list” link to admin views of user account pages
- ✓ Added “Primary Location” field to CareerForce and Partner Groups
- ✓ Refined user search pages
- ✓ Updated label of “Career Seeker” profile type to “Job Seeker”
- ✓ Applied styling updates to admin views of user profile pages
- ✓ Created new Vetting Connections page for admin users
- ✓ Updated “Back to list” link destinations on admin views of account pages
- ✓ Refined access controls on admin views of account pages
- ✓ Updated page redirect after login via single sign-on
- ✓ Added helper text to staff profile page
- ✓ Removed “N/A” and “Staff” options from Account Settings tab
- ✓ Set up functionality to track changes to account roles and role permissions

- ✓ Implemented account lookup and recovery
- ✓ Refined two-factor authentication content in partner log-in workflow
- ✓ Documented translation process for two-factor authentication content
- ✓ Refined partner account request form
- ✓ Displayed account information on admin view of Partner profile
- ✓ Removed placeholder Events & Appointments block from Staff and Partner account dashboards

Back-end work:

- ✓ Confirmed functionality of analytics tags and triggers related to account creation via resume builder
- ✓ Work related to Auditing & Audit Logs:
 - ✓ Implemented separate hook/listener for resume preview logs
 - ✓ Captured audit trails and activity log events for resume uploads

- ✓ Finalized order and display of user account tabs
- ✓ Refined styling of user account pages
- ✓ Finalized Program taxonomy terms for Staff profiles
- ✓ Added titles to new and legacy user account tabs

- ✓ Corrected caching issue for User Identification and Back to List blocks
- ✓ Enabled private page content to display on Content Submissions account tab
- ✓ Excluded existing Staff accounts from triggering vetting connection
- ✓ Implemented process to auto-purge inactive Staff and Partner accounts
- ✓ Documented translation steps for Partner account registration form
- ✓ Applied Role Tier access controls to Profile entities

- ✓ Corrected User Identification block display issue
- ✓ Confirmed access controls from user search results
- ✓ Updated Job Seeker Lookup page link in Quick Links
- ✓ Updated login menu links in site header
- ✓ Removed “For Staff and Partners” link from header
- ✓ Approved designs for auto-population of Job Seeker account registration fields

- ✓ Added translation options to resume builder page
- ✓ Completed updates to Drupal modules
- ✓ Cleaned up legacy audit logging modules
- ✓ Adjusted role permissions for user data export
- ✓ Added admin-level password settings to Job Service Administrator role

Bug fixes:

- ✓ Corrected duplicate Resume Builder admin menu item
- ✓ Addressed session timeout message multi-click issue
- ✓ Fixed Administrative menu PHP error
- ✓ Corrected content workflow state errors due to user migration

What we accomplished: Sprint 151

Job seeker accounts (deployed to test site):

- ✓ Styled and placed block for LoginMN information
- ✓ Made LoginMN information block visible to admin users when viewing Job Seeker account pages
- ✓ Added LoginMN link to LoginMN information block
- ✓ Refined LoginMN information block
- ✓ Applied updated page structure to View Profile account page
- ✓ Hid Webform Submissions account tab for Job Seeker accounts

What we accomplished: Sprint 151, continued

Back-end work:

- ✓ Cleaned up discontinued Partner profile fields
- ✓ Researched potential impacts of removing Shortcuts page and menu item for Drupal admin users

Bug fixes:

- ✓ Corrected content spacing on Homepage and CareerForce location pages on mobile
- ✓ Fixed issue preventing user account tabs from being translated

What we accomplished: Sprint 152

Job seeker accounts (deployed to test site):

- ✓ Created custom module to provide tooltips
- ✓ Styled tooltip icon and pop-up helper text
- ✓ Removed placeholder Job Seeker registration form
- ✓ Reviewed options for maintaining consistent order of account tabs
- ✓ Disabled 'Extended Profile Type' field on user accounts
- ✓ Explored options for accordion formatting on Search Job Seekers page
- ✓ Cleaned up About Me page header text
- ✓ Updated LoginMN link in SSO block to ensure resolution
- ✓ Adjusted configuration options to prevent links from being added to Staff SSO blocks

Event Management (deployed to test site):

- ✓ Installed and evaluated module to support recurring events
- ✓ Added validation to module

What we accomplished: Sprint 152, continued

Back-end work:

- ✓ Completed update of Drupal core and applicable modules
 - ✓ Completed bug fixes required for update
 - ✓ Made necessary post-update styling adjustments
 - ✓ Addressed issue preventing Tailored Resumes section of My Resumes page from displaying as expected
 - ✓ Corrected error when navigating to My Resumes tab
 - ✓ Corrected error when accessing Group admin tabs
 - ✓ Adjusted bulleted list options for CKeditor
 - ✓ Fixed issue preventing CKeditor toolbars from displaying for content management
 - ✓ Fixed issues with CKeditor File Embed tool
 - ✓ Adjusted CKeditor link tool to display content suggestions
 - ✓ Completed patch cleanup
 - ✓ Ported Container bug patch
 - ✓ Locked ECA module at highest compatible version
 - ✓ Applied security patch for Role Delegation module
 - ✓ Set up audit logs of user account page views
 - ✓ Set up audit logs of account list export downloads
 - ✓ Removed Shortcuts link from admin local task menu
 - ✓ Built release branch for Drupal update

What we accomplished: Sprint 152, continued further!

Bug fixes:

- ✓ Adjusted user authentication settings to bring user back to the page they were trying to access before logging in with single sign-on
- ✓ Corrected issue preventing People search results from exporting as expected when filtered by Partner account type
- ✓ Updated Account Settings pages to remove placeholder SSO block
- ✓ Fixed issue preventing account information from displaying on admin views of inactive accounts without profiles
- ✓ Corrected issue preventing a block on the My Labor Market page from being updated
