## VRS Leadership Updates

#### **DEED-VRS Budget Updates**

With the addition of state match funds built into the base along with successful obtainment of Federal reallotment funds and continued cost saving measures, the VRS budget is stable.

#### Government Shutdown

VRS is closely monitoring developments at the federal level and is not immediately impacted by the federal shutdown.

VRS programs are supported by both state and federal funding and are therefore able to continue operations for the immediate future utilizing non-Federal funds.

This means that services have continued uninterrupted since October 1st, and services should proceed as usual.

#### Reminders

- An Invitation to Placement form <u>must</u> be completed by the VRS counselor and shared with the placement professional for all PBA's, E1MN PBA's, and Customized Employment referrals. IPS does <u>not</u> use the Invitation to Placement form.
- PBA's as part of IPS Projects do not require VRS RAM approval.
- Placement Plans must be agreed to and signed by the individual or the individual's representative, the VRS counselor, and the placement professional prior to initiating services.

## New Model for Introductory Career Services (ICS)

#### Online group classes

- ICS Representatives deliver classes- no longer assigned to schools
- Times offered throughout each school day
- Students come into classes from all over the state
- Pathful is a primary tool

#### School staff take lead on:

- Helping students apply for ICS
- Assisting students in registering for classes

...and then are provided email updates after each class

#### TWO TYPES OF SERVICES FOR STUDENTS

Vocational Rehabilitation Services (VRS), in close collaboration with schools, offers two types of services for students (age 14 up until 22) with IEPs, 504 plans or other medical/mental health documentation.

#### Introductory Career Services (ICS)

Help students with disabilities get an early start in career planning, and is typically geared toward youth in 9th, 10th and 11th grade.

#### **Full Career Services (FCS)**

May serve as a "next step" for students with disabilities who are typically in 11th and 12th grade (or 18-22 transition programming) to receive more individualized career services.

#### What are the services?

Free online courses for students to learn and explore within the five Pre-Employment Transition Services (Pre-ETS) as needed:

- ☑ Job exploration
- Work-based learning
- Training and college exploration
- ☑ Workplace readiness
- ☑ Self-advocacy

Based on each student's needs, services may include any of the five Pre-ETS, plus other services and supports during high school and after graduation to help with:

- Postsecondary education or training
- ☑ Finding a job
- ☑ Keeping a job

#### How long can a student receive services?

Available ONLY while enrolled in school.

As long as needed, until they reach their employment goal. People can apply or re-apply for services at any age.

#### How does a student access services?

School staff help students apply for ICS and then register for and complete courses that address unmet career development needs. School staff interested in helping high school students access FCS can contact the VRS counselor assigned to their school to discuss the application process.



#### Pre-Employment Transition Services (Pre-ETS) Authorizations

- Introductory Career Services (ICS): Are now delivered through online classes by VRS staff. ICS Representatives will **no longer** be authorizing for Pre-ETS through Community Partners.
- Full Career Services (FCS): When a VRS counselor identifies a Pre-ETS
  need for an FCS student that cannot be provided by a school, they may
  authorize to have the service provided by a Community Partner when
  necessary.
  - Support for Student Work Experiences: VRS can only support student work experiences, internships, and on-the-job evaluations (OJEs) outside of school hours (evenings, weekends, and school breaks). Note that planning for these activities can happen during school hours.

## VRS Announces Shift in the Provision of Introductory Career Services

Effective at the start of the 2025-26 school year, Vocational Rehabilitation Services (VRS) will be implementing a new model for providing Introductory Career Services (ICS). Students will have access to virtual courses and work directly with their school staff to navigate ICS.

Since 2019 VRS has made ICS available statewide to students with disabilities who are between ages 14 and 22 and potentially eligible for the full vocational rehabilitation program, also known as Full Career Services or FCS. Until now, ICS have been arranged for students by Pre-

## Community Partnerships Team Updates

### Community Partner Program Evaluation Pilot

This upcoming pilot will be aimed at CARF accredited partners who anticipate earning \$400,000/year or less through their DEED professional/technical contract with VRS.

#### The Program Evaluation will include:

- A questionnaire to be completed by the Community Partner (CP), a
  questionnaire for the VRS CP Liaison, and input from the VRS teams served by
  the partner
- A review of the Community Partner's questionnaire responses and a closer look at the various requirements and procedures laid out in the contract with VRS.
- An in-person site visit

## VRS Community Partner Training Pilot

- VRS has been using the YesLMS learning management system for several years due to its accessibility and ease of use
- VRS wanted to give community partners access to VR and disability related training
- We ran a VR Community Parter YesLMS pilot from July to September 2025 with 10 partner organizations and 18 individuals
- Pilot participants provided feedback the platform and training content on September 30, 2025
- VRS will begin plans for a statewide roll out in 2026

## Funding Notice
