Raws li cov lus pom zoo ntawd, Minnesota Legislature tau pom zoo rau ib txoj cai uas yuav muab tag nrho cov koom haum EIDBI los tso rau hauv ib qho kev tso cai ib ntus (provisional license) uas tsis pub dhau xyoo 2026.

Kev tso cai ib ntus no yuav pab li cas?

- Muab kev tiv thaiv kev noj qab haus huv thiab kev nyab xeeb ntau dua rau cov me nyuam thiab hluas uas tau txais kev pab EIDBI
- Tsim ib lub qauv tso cai los xyuas kom zoo, nyab xeeb, thiab ncaj ncees rau cov kev pab uas tab tom muab
- Muab kev qhia meej, kev cob qhia, thiab cov qauv kom pab cov koom haum muab tau kev pab zoo
- Tsim kev lav ris thiab xyuas kom cov nyiaj se ntawm pej xeeb raug siv kom tsim nyog

DHS kuj tab tom ua hauj lwm nrog EIDBI Advisory Council los tsim kom muaj cov qauv tso cai dav thiab yuav muab cov lus pom zoo no rau Legislature thaum txog lub Ib Hlis xyoo 2027. Cov uas xav koom rau hauv txoj kev tsim cai no yuav muaj sijhawm koom tes thiab qhia tswv yim. Rau Cov Koom Haum

- Cov chaw pab cuam uas twb cuv npe nrog Minnesota Health Care Programs (MHCP) lawm tseem txuas ntxiv tau los muab kev pab rau lub sij hawm uas tab tom hloov mus rau qhov kev tso cai ib ntus no (provisional licensure).
- Yuav muaj them tus nqi \$2,100 rau txhua daim ntawv tso cai.
- *DHS* yuav pib muab cov kev tso cai ib ntus pib xyoo 2026.
- Nyob ntawm seb muaj pes tsawg daim ntawv thov tau txais, tej zaum nws yuav siv ob peb hlis tom qab koj xa daim ntawv thov kom tau txais daim ntawv tso cai ib ntus.
- Tag nrho cov koom haum uas twb muaj lawm yuav tsum xa lawv daim ntawv thov uas tsis pub dhau Hnub Tim 31 lub Tsib Hlis xyoo 2026.
- Cov koom haum uas tsis xa daim ntawv thov raws sij hawm ntawd yuav raug tshem tawm thiab yuav tsis muaj cai los muab kev pab.
- Tag nrho cov koom haum yuav tsum hloov kho lawv tsab cai thiab kev qhia txog kev qhia tawm kev tsim txom thiab xyuas kom meej tias cov neeg ua hauj lwm txhua tus tau txais kev cob qhia txog thaum twg thiab yuav qhia li cas yog muaj kev tsim txom. Yog muaj kev txhawj xeeb txog kev pab cuam los sis muaj kev liam tias muaj kev tsim txom, thov qhia ncaj qha rau DHS rau cov me nyuam (651-431-6600) thiab rau Minnesota Adult Abuse Reporting Center rau cov hluas muaj hnub nyoog 18 txog 21 xyoos (1-844-880-1574).

Rau Cov Tsev Neeg Thiab Cov Neeg Tau Kev Pab
