Also, reunification of a child with a parent is not required if a parent has been convicted of a registration offense.
260C.178	Emergency Removal	An emergency removal petition can be filed stating a prima facie case that a parent is a registered offender
260C.503	Permanency Proceedings	The responsible social services agency must ask the county attorney to immediately file a termination of parental rights petition when the parent has committed an offense that requires registration. That requirement does not apply if the social services agency and the county attorney take alternative action transferring custody or under a CHIPS case plan and

244.053	Notice of Release of Certain Offenders	Provides for notice of release to law enforcement where a predatory offender will be released, victims, witnesses who testified against them, and any person specified in writing by the county attorney.
244.057	Predatory Offenders; Household With Children	A corrections agency supervising an offender required to register shall notify appropriate child protection agency before authorizing the offender to live in a household with children.

244.10	Sentencing Hearing	Provides for notice to victims and witnesses who have requested notice and to law enforcement agency where offender will be residing if he is on probation.
244.17	Challenge Incarceration Program	Registered offenders cannot participate in Challenge Incarceration Program.

617.247	Possession of Child Pornography	One of the bases for higher felony counts is if the person commits the crime and is a registered predatory offender
624.714	Carrying of Weapons Without Permit	Except when acting under the authority of other law, it is a misdemeanor for a registrant to carry a pistol, whether or not the carrier possesses a permit to carry issued under the section.
