A facility shall be inspected at least daily for contraband, evidence of breaches in security, and inoperable security equipment, and shall document the inspection.

Inspection Findings:

The facility was not able to provide documentation for daily inspections and was unable to verify that they are being completed.

Corrective Actions:

The facility shall develop a procedure for the daily inspection of contraband, evidence of breaches in security, and inoperable security equipment. The inspections shall be documented in a manner in which it is clearly identified. Submit this procedure to the Department of Corrections within 15 days of receipt of this report. The inspector will continue to monitor for compliance.

Corrective Actions:

Although the County is moving forward with building a new facility, it is strongly recommended that the facility continue to proactively address its aging infrastructure to ensure the health and safety of the staff and inmate population.

INSPECTION COMMENTS

PHYSICAL PLANT INSPECTION:

The lack of storage noted in the 2024 inspection report to include the intake area is still a concern. The intake area is insufficient for the number of bookings conducted annually. The intake holding cells and property storage area are not integrated into this space, making this area staff intensive.

Due to the facilities age and history of past inspection findings, the facility will remain on an annual inspection cycle to establish a record of consistent compliance with the rules.

JJDPA Compliance

On April 9, 2025, a Juvenile Justice and Delinquency Prevention (JJDP) Act audit was conducted. The Beltrami County jail has no approval to hold delinquent juveniles. According to DOC Portal and facility records the Beltrami County jail held or processed zero (0) juveniles from October 2024 through the date of inspection.

DSO: No violations determined.

Jail Removal: No violations determined.

Sight and Sound Separation: No violations determined.

Based on these facts and documentation that reviewed, no violations of the JJDP Act were identified during the Beltrami County Jail inspection.
