RULE COMPLIANCE DETAILS

Inspection Findings:

1. 2960.0050 RESIDENT RIGHTS AND BASIC SERVICES. Subpart 3.A.. Basic rights information.

In review of five resident files, there was no documentation that residents were given a copy of the resident rights at the time of intake. Documentation showed that residents were given a copy of the resident handbook at intake, however the rights were not included in the handbook.

Corrective Actions:

InspectionType :Biennial

Ensure that each resident has a copy of the resident rights at the time of intake. During this inspection a copy of the rights were included in the new print of the resident handbook. Once the facility receives the new books, they will be placed in circulation. Until the new books were in place, each resident received a paper copy of the rights at intake.

1. 2960.0360 SECURITY POLICIES AND PROCEDURES. Subpart 1. Content of policies and procedures.

A license holder who offers correctional program services must develop security policies and procedures regarding the following: A. control and recovery of contraband; B. delivery and service procedures; C. prohibition of firearms and other weapons in resident areas and measures to ensure that weapons are inaccessible to residents; D. search procedures; E. escort of residents outside the secured area; and F. one half hour interval well being checks, when residents are not under direct supervision.

Inspection Findings:

F. In review of three days/nights, September 20-21, 24-25, and 25-26, 2023, of well-being checks showed that they were completed and documented every 20 minutes, however video review of one of the three overnight shifts of well-being checks showed that staff went to each room but did not make a considerable pause to observe the resident's status.

Corrective Actions:

Immediate action must be taken to ensure that staff are pausing at each room to clearly observe the well-being of the resident.

INSPECTION COMMENTS

The Carver County Temporary Holdover Facility inspection was completed on September 26, 2023, using Minnesota Rules, Chapter 2960, governing juvenile residential facilities.
