# Minnesota's Mandatory Minimums for First- and Second-Degree Controlled Substance Crimes

Outside the scope: drug-related mandatory minimums under Minn. Stat. § 609.11

#### First-Degree Controlled Substance Crime

#### **SELL**

- 17g cocaine/meth
- 10g cocaine/meth with firearm
- 10g cocaine/meth with two aggravating factors
- 10g/40du heroin/fentanyl
- 50g other narcotic drug
- 50g/200DU amphetamine/ phencyclidine/hallucinogen

#### **POSSESS**

- 50g cocaine/meth
- 25 cocaine/meth with firearm
- 25g cocaine/meth with two aggravating factors
- 25g/100DU heroin/fentanyl
- 500g other narcotic drug<sup>S</sup>
- 500g/500DU amphetamine/ phencyclidine/hallucinogen<sup>S</sup>
- Unlawful cannabis: 50kg flower, 10kg concentrate, 1kg infusion<sup>S</sup>

### Mandatory Minimum #1: Aggravated First-Degree Controlled Substance Crime – 3(d)

- Can be any offense on the first slide except those marked with "S"
- Ignore the amounts; all amounts must be at least 100g or 500DU
- In addition, the defendant or an accomplice must possess a firearm – or – the offense must involve two aggravating factors
- Mandatory minimum: Presumptive Guidelines duration (at least 86 months), no lower range
- Not waivable

## Mandatory Minimum #2: High-Amount First-Degree Controlled Substance Crime – 3(c)

- Can be any offense on the first slide except those marked with "S"
- ullet Ignore the amounts; all amounts must be at least 100g or 500DU
- No firearm or aggravating-factor requirement
- Mandatory minimum: Presumptive Guidelines duration (at least 65 months), no lower range
- Not waivable for SALE
- Waivable for POSSESSION, but only if the defendant has no prior convictions for first, second, or third-degree controlled substance crime

## Mandatory Minimum #3: First-Degree as a Subsequent Controlled Substance Offense – 3(b)

- Can be any offense on the first slide—including those marked with "S"—or meth manufacturing
- Must have committed the new crime within 10 years of discharge from a prior sentence for a first- or second-degree controlled substance crime conviction
- Four-year mandatory minimum
- Not waivable

# Mandatory Minimum #4: Second-Degree as a Subsequent Controlled Substance Offense

- Can be any second-degree offense
- Must have committed the new crime within 10 years of discharge from a prior sentence for a first- or second-degree controlled substance crime conviction
- Three-year mandatory minimum
- Not waivable
