## **INSPECTION COMMENTS**

Heartland Ranch Inc.

The Heartland Ranch annual inspection was completed on August 20th, 2020, using Minnesota Rules, Chapter 2960, governing juvenile residential facilities. Sections of the 2960 standards that are applicable to the programs at this facility include: Administrative, Group Residential, Corrections and Restrictive Procedures.

This scheduled inspection visit consisted of a physical plant safety and security inspection. The physical plant inspection included resident living areas, resident bedrooms, bathrooms, visiting/meeting/group rooms, and gym/recreation areas.

The inspection also included discussions with multiple staff; supervisors, direct care staff, human resource/training staff, nursing and recreation staff and administration, as well as discussions with residents and observation of staff interactions with residents. Documentation review included staff personal and training files, resident files, daily logs, treatment plans, menus, recreation schedules, grievance documentation, well-being checks and other pertinent facility documentation. There was also a review of the facility policy and procedure manual, resident handbook and overviews for the programs.

The following comments and concerns are a result of the inspection. While these may not be specific rule violations, these are areas that provided constructive feedback to help address potential facility issues.

Comments:

1. The facility response to COVID-19 follows CDC guidelines and included masks for residents and staff, hand sanitizer, and temperature checks. There have been no positive cases or home visits allowed thus far. Residents are not required to wear masks outside or in their living unit.

2. Administration staff is proactively working on updating policies and since the last inspection has changed a policy concern regarding side hugging residents.

3. Grievance procedure issues from last inspection have been corrected.

4. Facility added barriers to the handicapped railings as suggested in the last inspection.

Concerns not noted in formal inspection:

1. Consider requiring staff to spend more time on well-being checks; these are being done, however viewing of resident seems to be quickly completed. They are doing these at irregular intervals, which is positive, rather than at the same time, each time.

2. Consider changing the policy regarding female staff assistance with hair grooming for residents.

3. Consider additional staff training on report writing. Some reports are written briefly, without supporting information.

Overall, the inspection went very well. There were great discussions with supervisors and administration. All appear to be appreciative of feedback and motivated to take actions necessary for continued positive improvement. Current administration has taken initiative to make positive changes in recent years and the overall environment at the facility is positive. Heartland Ranch will be placed on biennial inspections.
