- June 17, 2023, Parole granted by Commissioner and Advisory Panel to begin consecutive sentence (A3): 15-year sentence for Murder 1<sup>st</sup> Degree Premeditated. Original confinement release date: June 21, 2033. Termination Date: June 17, 2038
- February 10, 2025, Minnesota Board of Pardons granted commutation on consecutive sentence (A3) making Mr.
   Netland immediately eligible for discretionary early supervised release on sentence A3. The Supervised Release
   Board may, in its discretion, grant him supervised release at any time with conditions of release as deemed appropriate.
