The Jail Administrator was prepared and organized for the inspection. Training is exceptional and documentation was detailed and organized. All staff have completed the FTO Training Program as part of their training.

The Program Manager has done a great job in maintaining creative programming during the COVID-19 Pandemic.

The facility will resume on site visiting on March 22, 2021.

Well-being check compliance continues to be of high importance for the facility. Added trainings including video have been added to enhance this importance.

The need for additional cameras was noted and already budgeted.

Since the facility is operating at an extremely high level of compliance they will be placed on biennial inspections.
