The foster home is clean and well maintained. Foster parents are up to date on training.

Comments:

1) Medication administration documentation should to be more formal. There is a log in a notebook rather than a form. Consider formalizing this process with a designated form with all required information.

2) Ensure that all resident files have a case plan from the placement agency with information required, medical visit data, and other required documents. Consider replacing current folders with folders that have separate designated labeled areas for medical/education/legal/intake, etc.
