It is mandatory that the facility provide an orientation session for new employees. There must be a minimum of 30 hours of training that is relevant to staff duties and the population served. The training must be documented.

Inspection Findings:

One of three personnel files reviewed did not contain documentation of orientation training.

Corrective Actions:

Immediately and on an ongoing basis, the license holder must comply with all 2920 standards regarding orientation for new employees.

2. 2920.3900 MANTOUX TEST OR CHEST X RAY REQUIRED.

It is mandatory that staff and residents by screened for tuberculosis according to Minnesota Statutes, section 144.445.

Inspection Findings:

One of three resident files reviewed did not contain documentation of an annual follow-up tuberculosis screening per state statute 144.445

One of three personnel files reviewed did not contain documentation of 2024 or 2025 annual follow-up tuberculosis screenings per state statue 144.445.

Corrective Actions:

Immediately ensure all staff and residents are screened for tuberculosis within the required time frame per state statute 144.445. Within 30 days of receipt of this order, current staff and residents must all be screened and documentation maintained in the files.

The facility does not have a referral form that includes all elements of this Rule part.

Corrective Actions:

Within 30 days of receipt of this report, the facility must develop a referral form that includes all elements of this rule part and submit it to the Department of Corrections for review and approval.
