### **RULE COMPLIANCE DETAILS**

#### **INSPECTION COMMENTS**

The new facility opened in October 2024, a six-month inspection was conducted in March of 2025, followed by this annual inspection.

While reviewing documentation pertaining to 2911.5450, the facility was in compliance with the rule, however it is recommended to create a more thorough inventory checklist to ensure accountability when culinary tools are being used, add specifics to facility policy to include the accountability of utensils while in use and ensure staff is trained on the procedure to inventory all kitchen utensils at the designated time.

The medical screen is thorough and includes all elements of 2911.5800.6, however during the inspection a computer glitch was identified in the transfer of information from the tablet being used in booking and the inmate's electronic file. The issue is being address by IT.

The facility will move to biennial inspections.

## **JJDPA Compliance**

Compliance Report for the monitoring of facilities according to the Juvenile Justice Delinquency Prevention Act of 2002.

On September 29, 2025, a Juvenile Justice and Delinquency Prevention Act audit was conducted. The Rice County Jail has received a "Rural Exception" to the Juvenile Justice and Delinquency Prevention Act (JJDP). This allows the facility to hold a delinquent juvenile up to 24 hours, excluding weekends and holidays. There are three core requirements that are looked at during our facility review. Those core requirements are Deinstitutionalization of Status Offenders (DSO), Removal of Juveniles for Adult Jail and Adult Lockups (Jail Removal), and Sight and Sound separation.

According to the DOC Portal System, the Rice County Jail has held zero (0) juveniles during the federal fiscal year. The findings are as follows:

DSO: I did not find any violations of the facility holding status offenders in the jail.

Jail Removal: I did not find any violations for the jail removal standard.

Sight and Sound Separation: The facility design and policies allow for proper sight and sound separation. Rice County does not hold delinquent juveniles in the facility per their current policy.

The facility does not participate in any "Scared Straight" programs for any youth that are under public authority.

Court Holding: No juveniles are held in the Rice County Jail.

Based on the documentation reviewed, I did not find any violations of the JJDP Act during the Rice County inspection.
