Upcoming Review Hearings

- * Previously, lawmakers formally repealed life sentences without parole for juveniles. Beginning July 1, 2024, a new Supervised Release Board (hereafter referred to as the "Board") was implemented in Minnesota. Any person who committed their crime when they were under 18 years old and are serving one or more life sentences or determinate sentences with minimum terms of imprisonment of more than 15 years is eligible for review by the Board. The period of incarceration may be longer depending on the number of consecutive sentences a person received. For these cases, the five-member supervised release board expands to include two juvenile experts who will make decisions on parole.
- ** Public Notice of Release Hearing Murder of a peace officer or correctional officer: Minnesota Statute 244.05, Subd. 9(a)(b), requires the commissioner of corrections to post on the department website information about the hearing. The law further provides for members of the public to submit a written statement.
