Task Force on Mandatory Minimum Sentences

Workplan (Updated 12-01-2025)

Background

In 2025, the Minnesota legislature ordered the creation of a task force to examine mandatory minimum sentencing. Specifically, the Task Force on Mandatory Minimum Sentences is "established to collect and analyze data on the charging, convicting, and sentencing of persons to mandatory minimum sentences; assess whether current laws and practices promote public safety and equity in sentencing; and make recommendations to the legislature."

During the first Task Force meeting, the group created three subcommittees:

- Data: explore available secondary data regarding mandatory minimum sentences and the extent to which available data can answer various research questions
- Legal analysis: analyze Minnesota statutes and comparative state statutes and legal issues pertaining to mandatory minimum sentences
- Stakeholder input: contract with a vendor to conduct primary data collection with people affected by mandatory minimum sentences or professionals with extensive knowledge of mandatory minimum sentences

Figure 1 presents an overview of the activities the task force will complete by August 16, 2026 and the corresponding subcommittee that primarily leads each activity.

Make recommendations for legislative action, if any, on laws affecting the collection and reporting of data and the charging, convicting, and sentencing of persons for crimes with mandatory minimum sentences	All
