Don't forget, all gambling managers are required to complete at least one continuing education class conducted by the Board each calendar year. While the deadline is December 31st, we strongly recommend that you don't wait until the last minute—gambling managers who don't meet the 2025 requirement will receive a citation.

All our classes are free, and anyone interested in lawful gambling is welcome to attend—no pre-registration is required. We're excited to support your ongoing education and look forward to seeing you—in person or online—soon.

The Compliance Review Group (CRG), a committee of the Gambling Control Board, meets with licensees to conduct informal inquiries into alleged violations of lawful gambling statutes and rules. The information presented here is a condensed report of recently completed CRG conferences. The penalties imposed are based on specific and unique information reviewed for each licensee.

#### 00013 Coon Rapids Lions Club

Failure to maintain internal controls; failure to uphold the integrity of lawful gambling; operating lawful gambling in deceit of the public; employee participation in lawful gambling

- Pay \$2,000 civil penalty
- Gambling Manager license revoked
- · Corrective action plan including gambling oversight committee
- Any person with a theft, fraud, or gambling-related infraction may NOT be involved with gambling-related activities
- Submit an updated LG202: Internal Controls form
- CEO and new Gambling Manager must attend the in-person Gambling Manager seminar and pass exam
