- Industry Update
  - October gross receipts totaled \$423 million, which was up 4.5% over last year's October receipts of \$405 million.
  - FY25 YTD gross receipts (July through October) are at \$1.65 billion. This is up 3% over the same four months in FY24.
  - As a reminder, the new e-tab game standards established in the 23 legislative sessions go into effect at the close of business on 12/31/24. No games that don't meet the new standards will be allowed to be in play after this point. We will be sending emails out to GMs and CEOs over the next two weeks, but also work with your distributors to make sure you organization is ready to go.

#### Education

O Currently we have about 300 GMs who haven't taken their CE class and we'll be sending out notices this week. As a reminder we have classes online that satisfy this requirement.

#### Staffing

- The GCB has a new compliance specialist, Dan Dixon who started last week and is working out
  of the Roseville office, excited to get him trained up and welcome Dan.
- We also completed interviews last week in Hibbing for a field agent, so should be wrapping up that hiring process early this week.
