# MINNESOTA GAMBLING CONTROL BOARD MEETING MINUTES

March 17, 2025

Chair Janet Lorenzo called the monthly meeting of the Minnesota Gambling Control Board to order on Monday, March 17, 2025, at 10:01 a.m., at the Gambling Control Board Office, 1711 West County Road B, Suite 300S, Roseville, MN 55113.

## 1. Approval of Agenda

## 4. Director's Report

- Industry Update
  - FY25 YTD (July `24 Jan `25) gross was \$2.9 billion. This is up 2% over the same time period last year. For those seven months, electronic pull-tab receipts were up slightly more than paper pull-tab receipts.
  - February electronic pull-tab sales were down 21.5% over February 2024, but remember that February `24 was a leap year with an average of \$7.6M in daily sales. We won't have data on February 2025 paper pull-tab sales until the April board meeting.
  - A potentially good sign is that the rate that e-tabs has fallen since December was not as severe from January `25 to February `25. As always, we will continue to monitor.

#### Education

The in-person gambling manager seminar is going well. We are receiving a lot of positive feedback. The classes have been filling up quickly and we have had to put people on a waiting list. However, registration for May has slowed down some and we should be able to accommodate everyone who wants to attend by June.

#### Budget

We continue to operate under budget with no unexpected expenditures.

#### Staffing

 Currently in the process of making an offer for a licensing specialist position and have two job postings open for compliance specialists, all in Roseville.

#### Legislation

 Currently tracking bills that address tax relief for charities, but nothing right now that impacts how the GCB regulates the industry.

## 5. Committee Reports

• Compliance Review Group (CRG): The Compliance Review Group, a committee of the Gambling Control Board, meets with licensees to conduct formal inquiries into alleged violations of lawful gambling statutes and rules. To date, 16 organizations have been brought before the CRG, 12 organizations have completed all sanctions and are finished with CRG. Three organizations are scheduled to meet with the CRG later today. All three of these organizations are new to the CRG. The sanctions imposed by

the board are published in the Gaming News. If the organization works with their licensing and compliance specialists, many issues which cause organizations to come before the Compliance Review Group can be avoided.

Education and Outreach Committee: Education and Outreach Committee met last week to discuss the website updates. Website will have a focus on how charitable gambling serves different communities in Minnesota. The committee also discussed the new CEO training that will soon be available. Shoutout to GCB staff who creates knowledge materials for our elected officials, so they have current information on the agency. Discussed how internal education can also help prevent organizations from going in front of the Compliance Review Group.

David Bierman and Steve Lempelius, Eagan Lions #02228, wanted to address the board regarding the recent fund loss they experienced and for reconsideration regarding the denial.

Mike Banovetz, Ely Winton Rod & Gun Club #04828, stated concerns regarding the ethics of the organization.

Rachel Jenner, Executive Director, Allied Charities, addressed the board asking them to reevaluate guidelines for approving/denying fund losses.
