<sup>2</sup> Restriction in effect until two weeks after no longer involved in conduct.

<sup>3</sup> If not involved in the conduct of lawful gambling during the bingo occasion.

<sup>4</sup> Persons under age 18 may not participate in any form of lawful gambling, with the following exceptions:

a. A person under 18 may sell raffle tickets.

b. A person under 18 may play paper bingo ONLY if accompanied by a parent or guardian and if the event is exempt or excluded from licensing, or part of an annual community event.
