

### **Letter from the Commissioner**

I am honored to present the Department of Iron Range Resources & Rehabilitation (IRRR) Fiscal Year 2024 (FY24) annual report. The report details the activities of the agency from July 1, 2023 through June 30, 2024.

### **Investing in Our Region**

In FY24, IRRR invested \$46.9 million through 16 loans, four loan guarantees and 127 grants to support business growth. These investments leveraged a total of \$191.1 million in project funding. We also awarded 156 community grants totaling \$25.1 million, supporting projects valued at \$229 million. Additionally, we invested over \$6 million into education and \$9.2 million into supporting our mines and future mining initiatives. These investments strengthened our regional economy by creating and retaining jobs, expanding our tax base, enhancing education and public services and improving quality of life across northeastern Minnesota.

### **Diversifying and Building for the Future**

We have made meaningful strides in diversifying our service area's economy, with one of our largest initiatives being the investment of \$6.275 million into a new housing program. Housing availability remains a critical factor for economic growth and business retention across northeastern Minnesota. In response, we developed a housing initiative tailored to our communities, supporting both new construction and rehabilitation projects. In FY24, we funded 14 projects, which, when fully developed, may result in approximately 280 new housing units, over 80 rehabilitated units and more than 65 new lots for future development. By partnering with Minnesota Housing, local communities and private developers, we have maximized resources and impact, helping to bridge the gap between development costs and affordable rent or home ownership.

### A Vision for Growth

IRRR remains committed to expanding existing businesses and attracting new industries to the region. Our team actively seeks out opportunities, engaging partners locally and nationally, to ensure northeastern Minnesota stays competitive in a changing economy.

Looking ahead, we are confident in the region's potential. Our foundation is strong, and with continued collaboration, we are poised for lasting growth.

# DEPARTMENT OF IRON RANGE RESOURCES & REHABILITATION State of the Range, 2024

## MISSION AND VISION

The Department of Iron Range Resources & Rehabilitation (IRRR) is a state of Minnesota economic development agency that reinvests local taconite production taxes back into northeastern Minnesota businesses and communities to strengthen and diversify the economy. The IRRR Board is an advisory board consisting of state senators and state representatives elected from senatorial or legislative districts in which one-third or more of the residents live within the agency's service area. One additional state senator is appointed by the majority leader of the senate. The members are appointed in January of odd-numbered years and serve until January of the next odd-numbered year. The board chair during Fiscal Year 2024 was Representative Spencer Igo of District 7A.

**Investment in Giants Ridge:** Agency investment increases Giants Ridge's economic impact and contributes to the quality of life in the region.




# **FUNDING**

The Department of Iron Range Resources & Rehabilitation is funded by a portion of a local taconite production tax paid by mining companies on each ton of iron ore pellets produced. The tax is paid by mining companies in lieu of property taxes. Prior to the agency receiving funds, dedicated amounts of the tax are legislatively distributed to local governments, schools and counties. The commissioner presents an annual budget for approval to the Iron Range Resources & Rehabilitation Board and governor.

# **SERVICE AREA**

The Taconite Assistance Area is a region defined by Minnesota State Statute (§273.1341). It is the geographic area in which the agency is authorized to expend its funding. The service area encompasses 13,000 square miles in northeastern Minnesota, including 53 cities, 134 townships, 15 school districts and portions of four Tribal Nations.

### TACONITE ECONOMIC DEVELOPMENT FUND

The Taconite Economic Development Fund was established by the 1992 Minnesota Legislature. Currently, in years when the total industry production exceeds 30 million tons, up to 25.1 cents per ton of the taconite production tax may be rebated to northeastern Minnesota iron ore mining operations. The rebate must be used for:

- Workforce development.
- Concurrent reclamation.
- Plant and stationary mining equipment.
- Facilities for the producer.
- Research and development in Minnesota on new mining or production technology.

### IRON RANGE HIGHER EDUCATION ACCOUNT

The Iron Range Higher Education Account was established by the 2008 Minnesota Legislature. The Iron Range Higher Education Committee advises the commissioner on providing higher education programs conducted at educational institutions in the Taconite Assistance Area. Programs are funded by five cents per taxable ton of the taconite production tax that are placed in the Iron Range Higher Education Account. The Iron Range Higher Education Committee, after consultation with the Iron Range Resources & Rehabilitation Board, approves expenditures from the account.

### IRON RANGE SCHOOLS AND COMMUNITY DEVELOPMENT ACCOUNT

The Iron Range Schools and Community Development Account, formerly the Iron Range Consolidation and Cooperatively Operated School Account, was established by the 2014 Minnesota Legislature. For distributions in 2024 through 2032, the account is funded by 24 cents per taxable ton of the taconite production tax along with funds from occupation taxes generated annually, and any other amounts provided by law. The money in the account can be used to help school districts, within the Taconite Assistance Area, pay off bonds for approved building projects and other school-related costs.
