



- It is in the basement of the Courthouse which requires a fob for access normally. Any patrol who asks will be allowed to access the law library.
- It is unlocked and open from 8:30 a.m. 4:30 p.m. Court administration begins a little earlier, at 8:00 a.m.
- it remains locked due to a county IT server in the same room, however, public and attorneys are welcome to use it during business hours. We simply unlock it for their use.
- Locked but fully staffed so we buzz people in as they come to the door.
- Mon. Fri. 8 a.m. to 5 p.m. (longer than court hours, but the building is open at least 12 hours per day)
- 8:00am-4:30pm Monday through Friday open to public


Q3: Does your library location have anyone hired or assigned to assist with the library?








Q7: How many hours per week is this person (or people if more than 1) available to assist patrons?






Q11: Does your library have a chair and table at which a patron can sit to work?


Q12: Does your library have a computer? (This computer would be different from the court-provided Self-Help terminal or the Legal Kiosk.)








- The Law Librarian II supervisor. She works for the County Public Library system. Her title is Library Division Manager.
- The librarian prepares the invoices, the Board's Executive Committee approves the invoices, the librarian pays the invoices.
 We are separate from the County.

- The current law library board president, the resident Judge (who is also on the board) and the board secretary (who is a court administrator office staff member) all sign the statements and then the secretary forwards them to the county for payment.




Q20: Does your library have a website?


Q21: Is your library listed as a department on your county's website?


